DECREE

THIS MATTER coming on now for entry of decree herein, plaintiffs appearing by their attorneys, Kilkenny & Fabre, and the defendants or any one of defendants appearing not, neither in person nor by attorney, and the default of each and all of the defendants having been entered herein and there being no requests for findings of fact or conclusions of law,

IT IS ORDERED, ADJUDGED and DECREED that the portions of the findings and decree of the Circuit Court of the State of Oregon for Umatilla County entered in the suit entitled "In the Matter of the Determination of the Relative Rights of the Various Claimant's to the Waters of the Umatilla River and Its Tributaries, a Tributary of the Columbia River in Umatilla County, Oregon" and which describes a portion of the lands of Marion Jack to which water rights were adjudicated as follows, to-wit:

20 acres in the Northwest Quarter of the Northwest Quarter;
10 acres in the Southwest Quarter of the Northwest Quarter and
20 acres in the Southeast Quarter of the Northwest Quarter of
Section 32, Township 2 North, Range 32 East of the Willamette
Meridian in Umatilla County, Oregon.

be and the same are hereby amended and corrected so that the same shall read as follows,
to-wit:

20 acres in the Northwest Quarter of the Northwest Quarter;
10 acres in the Southwest Quarter of the Northwest Quarter and
20 acres in the Southeast Quarter of the Northwest Quarter of
Section 34, Township 2 North, Range 32 East of the Willamette
Meridian in Umatilla County, Oregon.

IT IS FURTHER ORDERED, ADJUDGED and DECREED that Lewis A. Stanley, State Engineer of the State of Oregon, correct the records in his office to conform to this decree and that the certificate of water right heretofore issued to said Marion Jack describing his land to which a water right is so adjudicated as being in Section 32, Township 2 North, Range 32 East of the Willamette Meridian in Umatilla County, Oregon be cancelled and that a new certificate of water right be issued covering said lands as being in Section 34,


