DECREE ON
SUPPLEMENTAL FINDINGS

The State Engineer of Oregon, heretofore on the 8th day of June, 1960, filed with this Court his Supplemental Findings of Fact and Order of Determination as to the extent to which the inchoate water right allowed in the name of the Sidney Irrigation Cooperative of Jefferson, Marion County, Oregon, by decree of this Court in the above entitled matter, entered on January 30, 1945, has been completed and perfected, and did procure from this Court an order fixing October 18, 1961 at the hour of 9:00 o'clock A. M. as the time at which said Supplemental Findings of Fact and Order of Determination would be heard by this Court.

Notice of said hearing and the time fixed therefor was duly served on Mr. David Wied, Secretary, Sidney Irrigation Cooperative, Jefferson, Oregon, as attested by Proof of Service of Notice, filed by the State Engineer of Oregon with the Clerk of this Court on the 18th day of September, 1961.

It appearing to this Court that no objections or exceptions to said State Engineer's Supplemental Findings of Fact and Order of Determination have been filed herein, and this Court having duly considered the matter, finds that said Supplemental Findings of Fact and Order of Determination of the State Engineer, determining the extent to which the inchoate water right of the Sidney Irrigation Cooperative, as allowed by decree of this Court, dated January 30, 1945, has been completed and perfected, should be affirmed.

It is therefore hereby CONSIDERED, ORDERED, ADJUDGED AND DECREED that the Supplemental Findings of Fact and Order of Determination of the State Engineer in the above entitled matter, be and the same are hereby in all things affirmed and are made the findings of Fact and Decree of this Court.
