DECREE AFFIRMING THE FINDINGS OF FACT
AND ORDER OF DETERMINATION OF THE
STATE ENGINEER OF OREGON

The State Engineer of Oregon, having heretofore made his Findings of Fact and Order of Determination herein, determining and establishing the several rights to the use of the waters of the above-named stream and its tributaries, and there having been filed with the Clerk of this Court on the 13th day of March, 1972, the original evidence filed with said State Engineer, and certified copies of the maps of record in said State Engineer's office in connection with said determination, and a copy of the Findings of Fact and Order of Determination of said State Engineer, as the same appears of record in his office, and said State Engineer having thereupon procured from this Court an order fixing June 16, 1972, as the time at which the determination herein would be heard by this Court, and notice of said hearing and the time fixed therefor having been duly and regularly given, in the manner required by law, to all parties interested, and it appearing to this Court that no objections or exceptions thereto have been filed herein, and this Court having duly considered the matter, finds that said Findings of Fact and Order of Determination of the State Engineer determining the relative rights to the use of the waters of Rickreall Creek and its tributaries should be affirmed.

It hereby is CONSIDERED, ORDERED, ADJUDGED AND DECREED that said Findings of Fact and Order of Determination of the State Engineer hereby are affirmed, and the same hereby are considered, ordered and adjudged to be the determination, adjudication, and establishment of the relative rights to the use of the waters of Rickreall Creek and its tributaries, and it is FURTHER ORDERED that said Findings of Fact and Order of Determination of said State Engineer be entered in the journals of this Court as the findings and determination of this Court in the above-entitled matter.
