DECREE

The order of determination of the State Water Board having been filed on January 16, 1914, with the County Clerk of Crook County, Oregon, in which the rights of the various claimants to the waters of Crooked River, are determined; by order of the Court March 12th, 1914, was set as the day for hearing of arguments on the exceptions to such findings; and it appearing at such hearing that the following persons had filed exceptions, to-wit: M. R. Biggs, R. A. Bland, C. S. Congleton, Mrs. Mary Connell, P. B. Davis, Thomas J. Ferguson, F. Fred Hoelscher, C. M. Lister, H. J. Lister, Joseph Lister, C. H. Nelson, John O. Powell, R. M. Powell, J. C. Pritchett, Francis V. Smith, Carey W. Foster, J. R. Knox, S. S. Stearns, Addie S. Kimble and M. A. Black, and Prineville Land and Live Stock Company; that after hearing of arguments of counsel for the respective exceptors, the court being fully advised in the premises,

It is ORDERED, ADJUDGED and DECREED that the findings of fact and order of determination of the State Water Board heretofore filed in the office of the County Clerk of this County, on January 16, 1914, is hereby confirmed in all things, except as in this decree modified or set aside.

## I.

That Finding XIV is confirmed except as to the lands of M. R. Biggs, John O. Powell and S. S. Stearns. The amount of water to be delivered to these lands shall not exceed six (6) acre feet per acre per year.

## II.

That Finding XVII is confirmed except as follows:

(a) The words "that the water master of the district in which said stream is situated shall in no case limit the diversion of any water user under this decree to a flow for irrigation purposes of less than 1/80 of a second foot for each acre of land irrigated", are omitted.

(b) That in order to irrigate the lands of M. R. Biggs, John O. Powell and S. S. Stearns, it is necessary to have a sufficient head of water; that six (6) acre feet is sufficient water to irrigate each acre of land, and a flow of one-sixtieth (1/60) of a cubic foot per second per acre of water, for five and one-third (5-1/3) months will deliver said six (6) acre feet; that the water master shall in no case limit the diversion of water by said Biggs, Powell and Stearns to a flow for irrigation purposes of less than one-sixtieth (1/60) of a second foot for each acre of land irrigated, or its equivalent in case of rotation.

## III.

That Addie S. Kimble and M. A. Black and their predecessors in interest have initiated appropriations of water from Crooked River and its tributaries

by the construction of ditches and diversion works, and preparing lands, and have actually irrigated and applied water to approximately 569 acres; that these claimants have not had sufficient time within which to complete their appropriations, although due diligence has been used by them; that said claimants be and the same are hereby allowed until October 15, 1914, within which to complete such appropriations; that upon the expiration of the time limited herein, said claimants or their successors in interest shall offer proof as to the completion of such appropriations, said proof to be made to this court at its regular term, namely, the first Monday of December, 1914, at nine o'clock, in the Court House, at Prineville, Oregon; and that the above mentioned claimants be allowed to divert water from the stream in an amount sufficient to irrigate the number of acres, or any part thereof, as set forth in the following tabulation, but not to exceed the rate of one-eightieth ( $1/80$ ) of a cubic foot per second for each acre irrigated:

## IV.

That Finding XXVIII is confirmed except as to the rights of M. R. Biggs; R. A. Bland; C. S. Congleton, (successor in interest to Grant Miller); Mrs. Mary Connell; P. B. Davis, Thomas J. Ferguson, (Successor in interest to Henry L. Parry); F. Fred Hoelscher, (successor in interest to Foster & Hyde); C. M. Lister; H. J. Lister; Joseph Lister; C. H. Nelson, John O. Powell; R. M. Powell; J. C. Pritchett, (successor in interest to Lettie Miller); Francis V. Smith; S. S. Stearns; and Almeda Orrick.

That the names and post office addresses of each of the above named appropriators of water from Crooked River and its tributaries, alphabetically arranged, together with the date of relative priority of each such appropriator; the maximum flow of such appropriation in cubic feet per second of time in case no rotation be arranged, and provided that the total quantity of water for irrigation is limited to six (6) acre feet per acre during each year for the lands of M. R. Biggs, John O. Powell and S. S.
