Now on this 11th day of January, 1915, this cause coming for a decree upon the findings of fact and order of determination of the State Water Board of the State of Oregon, dated July 17, 1914, and filed in the office of the County Clerk of Hood River, County, Oregon; and it appearing that certain persons have filed exceptions to such findings of fact and order of determination of the State Water Board, and that after hearing of arguments of counsel for the respective exceptors, the court made certain correction and modifications in such findings, and having approved and adopted as the findings of this court the said findings of the State Water Board as so modified, and being now fully advised in the premises,

It is hereby ORDERED, ADJUDGED and decreed that the findings of fact and order of determination of the State Water Board heretofore filed in the office of the County Clerk of Hood River County, Oregon, is hereby confirmed in all things, except as in this decree modified or set aside:

I.

That Finding XVI is confirmed except as follows:

That the words "Abbot L. Clarke, five acres" be and the same are hereby stricken therefrom, and the words "Abbott L. Clarke, ten acres" are substituted therefor.

II.

That Finding XVII is confirmed except as follows:

That Troy Shelley be and he is hereby allowed an additional .19 second foot of the water of Spring Branch, for the irrigation of the following lands, which are in addition to the lands already described in the tabulation of his rights: 5 acres in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , Sec. 36: 10 acres in the SE $\frac{1}{4}$  SW $\frac{1}{4}$ , Sec. 25; in Township 2 North Range 10 East of Willamette Meridian.
