ORDER CORRECTING DECREE

This matter having come before the court at its regularly scheduled time for hearing on the 13th day of August, 1981, at 1:00 p.m., and the Petitioner being present, and the court having heard no objections to Petitioner's Petition to Correct Decree, and having read the records and files herein, and being fully advised in the premises,

IT IS HEREBY ORDERED, ADJUDGED and DECREED as follows:

1) The water rights on the SW 1/4 of the NE 1/4 north of Fish Creek, and of the NW 1/4 of the SE 1/4 north of Fish Creek, all situated in Section 32, Township 7 South, Range 39 E., W.M., in the County of Baker, State of Oregon, shall be adjudicated dated 1874 from Sand Creek water through the McCulloch and Weisner Ditch.

2) The NW 1/4 of the SE 1/4 south of Fish Creek, and the SW 1/4 of the NE 1/4 south of Fish Creek, all situated in Section 32, Township 7 South, Range 39 E., W.M., in the County of Baker, State of Oregon, are hereby adjudicated to have water rights dated 1865 from Rock Creek water through Solomon Coles Ditch or as presently noted through Moore Ditch.

3) In all other respects the original decree known as the Powder River Adjudication described by water certificate recorded at Page 4074, State Record of Water Rights Certificates, except for the changes above, shall remain the same and in full force and effect.


