DECREE.

Now on this day this matter coming on to be heafd on the motion of the exceptor, William B. Ewing, by his attorney, S. E. Notson, for a decree herein, and the Court having heretofore made and filed its findings of fact and Conclusions of Law, and based thereon, it is hereby

ORDERED, ADJUDGED AND DECREED, That the Findings and Order of Determination of the Relative Rights to the Waters of Willow Creek, and Tributaries, a Tributary of the Columbia River, filed in the above entitled matter by the Board of Control of the State of Oregon for Water Division No. 2, Gilliam and Morrow Counties, in so far as the same fix and determine the water rights of William B. Ewing, the exceptor herein, and not otherwise, be and the same hereby is corrected and modified as follows: The name High Ditch to be inserted in the list of Ditches from and through which the exceptor William B. Ewing may take and use water for irrigating the lands set forth in said Findings and Order of Determination as lands to which said William B. Ewing is entitled to water for irrigation from said William Creek.

Now on this day this matter coming on to be heard on the motion of the exceptor, Mary L. White, by her attorney, Sam E. Van Vactor, for a decree herein, and the Court having heretofore made and filed its Findings of Fact and Conclusions of Law, and Based thereon, it is hereby

ORDERED, ADJUDGED AND DECREED, That the Findings and Order of Determination of the Relative Rights to the Waters of Willow Creek and Tributaries, a Tributary of the Columbia River, filed in the above entitled matter by the Board of Control of the State of Oregon for Water Division No. 2, Gilliam and Morrow Counties, in so far as the same fix and determine the water rights of Mary L. White, the exceptor herein and not otherwise, be and the same hereby is corrected and modified to read as follows:

White by her attorney, Sam E. Van Vactor, has duly filed herein exceptions and a petition to correct said order of determination as to certain dates and acreage and clerical errors, and the court having duly heard the evidence in support of said exceptions and petition and made and filed its findings of fact and conclusions of law, and entered decree herein allowing said petition and corrections, and William B. Ewing by his attorney, S. E. Notson, having duly filed herein exceptions to said order of determination and a petition for the correction of an emission therein by inserting the name of "The High Line Ditch," in the list of ditches from and through which said William B. Ewing may take and use water for irrigation upon the lands set forth in said order of determination, and the court having heard the evidence in support of said exceptions and petition, and made its findings of fact filed herein, and an order and decree allowing said petition and correction, which said order and decree is duly entered herein, and there being no other objections or exceptions, the said order of final determination of the Board of Control filed herein on the 11 day of May, 1910, and the time for making and filing exceptions thereto having fully expired,

IT IS THEREFORE, PRDERED. ADJUDGED AND DECREED, by the Court that the findings and order of determination of the relative rights of the waters of Willow Creek and its
