SUPPLEMENTAL FINDINGS OF FACT AND ORDER OF DETERMINATION

Now at this time the above entitled matter coming before the Water Resources Director for consideration and for making supplemental findings as to the completion of the inchoate rights allowed by Decree of the Circuit Court of the State of Oregon for Marion County, in the name of the Willamette Valley Water Company, successor in interest, now Santiam Water Control District of Aumsville, Oregon, entered of record January 30, 1945; and it appearing that the time for the completion of said inchoate right, as set by said North Santiam River Decree, and as subsequently extended from time to time by orders of the Water Resources Director for good cause shown, has expired; that a field examination and survey of the lands reclaimed and irrigated in completion of said inchoate right was made during the period May through August 1978, March 1979 and July through August 1980, under the direction of the Water Resources Director; that maps of said survey have been prepared and are made a part of the record herein; that proof and evidence from individual water users in the Santiam Water Control District, showing the extent of the completion of said inchoate right, in accordance with the provisions of said North Santiam River Decree, together with proof and the sworn statement of the Secretary of Sidney Irrigation Cooperative, a transferee, has been taken and filed as a part of the record herein; the Water Resources Director now being fully advised in the premises, makes the following:

## SUPPLEMENTAL FINDINGS OF FACT

Under the provisions of Finding 36 of the Circuit Court Decree determining the relative rights of the various claimants to the use of the waters of North Santiam River and its tributaries, dated January 30, 1945, an inchoate water right was established in the name of the Willamette Valley Water Company, now Santiam Water Control District to the use of 300.0 cubic feet per second of the waters of the North Santiam River, with a date of priority of May 14, 1909, diverted through the Willamette Valley Water Company Ditch (Stayton District Canal), Mill Creek and ditches therefrom, for the irrigation of 24,000 acres of land, as described under the tabulation of water rights on pages 179 - 187 of said decree.

Since, at that time, the lands were not all reclaimed and under irrigation, the Santiam Water Control District was allowed an additional period of two years from the date of entry of the decree within which to make complete application of water, or within such further time as may be allowed by order of the Water Resources Director for good cause shown.

It appears that due diligence was shown in the execution of the work necessary for completion of said inchoate water right and that, upon proper application being made by said Santiam Water Control District, the Water Resources Director did extend the time for completion of said inchoate right from time to time, the last extension having expired on October 1, 1977.

Several transfers of the inchoate right were effected subsequent to the North Santiam River Decree. The transfers listed below were taken into consideration at the time of the field examination and survey of the lands. The lands found irrigated under the transfers, if any, are included in the tabulation of lands herein under Santiam Water Control District heading.

Certificate of water right number 20231 was inadvertently issued December 7, 1953 by the State Engineer, confirming Transfer No. W-45 of the inchoate water right to Turner Memorial Home for irrigation of 3.8 acres in the S 1/2 SW 1/4 NW 1/4, 6.2 acres in the N 1/2 NW 1/4 SW 1/4, Section 28, Township 8 South, Range 2 West, WM. These lands were found to be presently irrigated by Turner Memorial Home and are included in the tabulation of lands herein. Certificate of water right number 20414 was erroneously issued under Permit No. E-82 (Santiam Water Control District) to Lee V. and Willa J. Ohmart and Rudy F. and Lillian Calaba for irrigation of lands in the NW 1/4 and the N 1/2 SW 1/4, Section 31, Township 7 South, Range 2 West, WM and the SE 1/4 NE 1/4, Section 36, Township 7 South, Range 3 West, WM. This right should be issued a certificate of water right under the inchoate right allowed in the Decree under Proof No. 145 and Finding 36 in the name of Willamette Valley Water Company now Santiam Water Control District. The subject lands were found to be presently irrigated to a lesser extent then allowed under certificate No. 20414. Certificate No. 20414 should be canceled - No. 4 ed on and a new certificate of water right issued after the findings and order of determination are affirmed by the circuit court decree.

On March 1, 1960 Santiam Water Control District made application to the State Engineer, now the Water Resources Director for a change in place of use for 2,000 acres and location of diversion point for 25.0 cubic feet per second of the said inchoate right to the Sidney Irrigation Cooperative. The

Transfer Application S-126 was approved and October 1, 1960 was the date for completion of the change in place of use and point of diversion.

It appears that due diligence was shown by Sidney Irrigation Cooperative in the execution of the work necessary for completion of that part of said inchoate water right and that, upon proper application being made by said Sidney Irrigation Cooperative, the Water Resources Director did extend the time for completion of said inchoate right from time to time, the last extension having expired on October 1, 1973.

That thereafter and during the periods May through August 1978, March 1979 and July through August 1980, a field examination and survey of the lands was made, which disclosed that the lands which were being irrigated in completion of said inchoate right, were not strictly in conformity with the description of the lands which were allowed said inchoate right, as set out and described on pages 179 to 187 of said North Santiam River Decree and on Transfer Application S-26, but that said irrigated lands were within the ownership of the several landowners comprising said Santiam Water Control District and Sidney Irrigation Cooperative, and were being served through the distribution systems thereof.

## SUPPLEMENTAL ORDER OF DETERMINATION

The Claimant, Santiam Water Control District, is a municipal corporation of the State of Oregon, organized for the purpose of supplying water for irrigation use to the several contract individual landowners under its distribution system. At the request of Willamette Valley Water Company, predecessor to Santiam Water Control District, and in accordance with paragraph 36 of the Decree, water right certificates are to be issued to those landowners who have purchased water from the company or its successors-in-interest, provided satisfactory proof is filed with the Water Resources Director showing the lands have been irrigated and that the water right has been paid for in full. A description of said lands to which this right is determined to be appurtenant, is set out in the tabulation of lands herein.

The Claimant, Sidney Irrigation Cooperative, is a non-profit cooperative association, organized for the purpose of supplying water for irrigation use to the several individual landowners under its distribution system. The certificate of water right confirming the rights allowed herein is to be issued in the name of the Sidney Irrigation Cooperative, the lands involved are treated as a unit, and the water right made appurtenant to the specific tracts of land as determined to be reclaimed and irrigated. A description of said lands to which this right is determined to be appurtenant, is set out in the tabulation of lands herein.

That all persons, firms or corporations who had a claim that was not found developed in this proceeding or in the earlier inchoate right determination, are hereby found to have lost or forfeited the claim by failure to put the water to beneficial use and such claim is held for naught. Anyone who has failed to appear in this or earlier proceedings is held to be in default.

Now therefore, it is determined and ordered that the following described lands have been reclaimed and irrigated in completion of the inchoate water right allowed in the name of the Willamette Valley Water Company and that a water right is hereby allowed appurtenant to the specific tracts of land as set out in the following tabulation, showing the name of the present landowner, the total number of acres allowed said landowner, and a description of the acreage allowed as to government subdivision, section, township and range.
