On March 10, 1986, this cause came on regularly for entry of a judgment based upon "Supplemental Findings of Fact and Order of Determination, North Santiam River and its Tributaries, Marion County" filed by the Water Resources Director in the Circuit Court of Marion County on January 13, 1986, under the provisions of ORS 539-130.

It appearing to the court from the files, records and evidence that:

- l. A decree determining the relative rights of claimants to the use of the waters of North Santiam River and its tributaries was entered on January 30, 1945.
- 2. Finding 36 of that decree established an inchoate water right in the name of the Willamette Valley Water Company, allowing additional time in which to apply the water appropriated to a beneficial use.
- 3. On January 13, 1986, the Water Resources Director filed "Supplemental Findings of Fact and Order of Determination" as to the extent to which the inchoate water right has been completed and perfected.
- 4. The Water Resources Director procured from this Court an order fixing 9:00 a.m., March 10, 1986, as the time at which the determination herein would be heard by the court.
- 5. Notice of said hearing and the time fixed therefor has been duly and regularly given to all interested parties in the manner which is required by law.
- 6. No objections or exceptions to the Water Resources Director's Supplemental Findings of Fact and Order of Determination have been filed.
- 7. The Water Resources Director has submitted "Corrections to Supplemental Findings of Fact and Order of Determination, North Santiam River and its Tributaries, Marion County," dated March 10, 1986.

It is hereby ORERED, ADJUDGED and DECREED that the "Supplemental Findings of Fact and Order of Determination, North Santiam River and its Tributaries, Marion County," of the Water Resources Director, dated December 30, 1985, with corrections dated March 10, 1986, are affirmed and made final. It is further ordered that none of the parties hereto shall recover costs and disbursement in these proceedings.
