SUPPLEMENTAL FINDINGS OF FACT  
AND  
ORDER OF DETERMINATION

On August 15, 1910, petitions were filed with the Board of Control, now the Water Resources Department, requesting a determination of the relative rights of the various claimants to the use of water from Lost River and its tributaries. A water use investigation was conducted and a Findings of Fact and Order of Determination was prepared and filed with the Circuit Court of the State of Oregon for Klamath County on August 27, 1917. Exceptions were filed by two claimants and further investigation took place. A Supplemental Findings of Fact and Order of Determination was filed with the Court August 2, 1918. The final Decree in this matter was signed by D.V. Kuykendall, Circuit Judge on September 12, 1918. A Supplemental Findings and Order of Determination finalizing the inchoate rights allowed by the final decree was filed November 1, 1922. Circuit Judge, A.L. Leavitt signed the Decree for these rights February 23, 1923.

In 1961, two complaints were filed in Lake County Circuit Court and two complaints were filed in Klamath County Circuit Court which asked that the Watermaster "... be enjoined from interfering with Plaintiff's right of storage and the use of the waters ..." on land in the Lost River Drainage Basin. The Lake County complaints were transferred to Klamath County and complaints were combined into Case No. 61-170E.

An order signed by then Circuit Judge David R. Vandenberg, on June 29, 1961, referred this matter "... to the State Engineer for a full and complete determination of the respective rights to Lost River and its tributaries located in Klamath County."

A motion to modify the court's order of June 29, 1961, was filed on January 7, 1963, by the State Engineer through his attorney. The motion suggested a supplemental determination of the rights of Lost River rather than a full and complete determination. The motion was made on the ground that Court's Decree Equity No. 915, dated September 12, 1918, was res judicata as to the adjudicated rights of Lost River and its tributaries and barred a new, full and complete determination.

On the 2nd day of April 1979, Circuit Court Judge Ted Abram signed an order that "The Water Resources Director shall proceed with determination and adjudication of vested rights of parties on lands not included in the original adjudication and incorporate this determination with the original adjudication so that a full and complete adjudication of Lost River and its tributaries will be accomplished."

The above-entitled matter has now been considered by the Water Resources Director (Director), evidence and testimony have been taken, and the Director having carefully considered all such evidence and testimony and the engineering data and information

gathered in accordance with law, makes and orders to be entered of record in his office the following:

#### FINDINGS OF FACT AND ORDER OF DETERMINATION

(1)

The Lost River is formed by Clear Lake Reservoir in California at a spillway elevation of 4,477 feet, for which the main tributary is Willow Creek. The Willow Creek Basin lies easterly of Clear Lake Reservoir and has an area of 505 square miles of which 47 square miles are located in Oregon and 458 square miles are located in California. The remainder of the drainage basin tributary to Clear Lake Reservoir has an area of approximately 237 square miles and is comprised mainly of flat desert land with a few intermittent flow channels tributary to the reservoir.

Originally, Lost River drained into Tule Lake at an elevation of about 4,060 feet before Tule Lake was drained, diked and reduced in size to what is now called the Tule Lake Sump. A tunnel has been constructed through a high rim on the west side of the sump and water is pumped from the Tule Lake Sump through the tunnel into Lower Klamath Lake and eventually to the Klamath River. During initial construction of the Klamath Project by the Bureau of Reclamation, a diversion canal was constructed connecting the Lost and Klamath Rivers, which allows the diversion of Lost River flood flows into the Klamath River. There is approximately 447 feet fall between Clear Lake Reservoir and Tule Lake Sump. Of this 447 feet fall, there is 337 feet in the first 14 miles and only 110 feet in the last 66 miles of the stream. The 110 feet of fall is fairly uniform.

The Lost River drainage (excluding the area in California draining directly into the reclaimed Tule Lake area) consists of 1,505 square miles. The only major tributary stream to Lost River in Oregon is Miller Creek with a drainage area of 275 square miles. Miller Creek and its tributaries, Ben Hall Creek, Barnes Creek, Barnes Valley Creek, Long Branch Creek, Lampham Creek, Pitch Log Creek and Wildhorse Creek have a drainage basin with the longitudinal axis extending in a northwest-southeast direction approximately 28 miles long, starting at the divide with Sprague River drainage in Klamath County on the northerly side and at the divide with the Goose Lake drainage in Lake County on the east end. Construction for Gerber Reservoir on Miller Creek was completed in June 1925 by the U.S. Bureau of Reclamation. The reservoir has a capacity of 94,270 acre-feet.

The normal annual precipitation of Lost River Basin varies from 10 inches at Merrill to a maximum of 20 inches at the northeast side of the basin on Barnes Rim. Most winter precipitation falls as snow, particularly at higher elevations. Mid-winter rains are frequent in the lower elevation areas.

Pursuant to ORS 539.030, the Director fixed a time for the making of necessary surveys and examinations and beginning of the taking of such testimony as would enable him to determine the relative rights of the various claimants to the use of the waters of Lost River and its tributaries, not included in the original adjudication and subject to the provisions of ORS Chapter 539.

A notice was prepared setting forth the date when the Director would begin the investigation of the flow of water in the Lost River and its tributaries, and the existing works for the utilization of waters thereof. The notice was published in two issues of the Lake County Examiner, a newspaper printed and published weekly at Lakeview, Lake County, Oregon, and of general circulation in Lake County; and in two issues of the Herald & News, a newspaper printed and published daily at Klamath Falls, Klamath County, Oregon and of general circulation in Klamath County; said two issues of the Lake County Examiner and the Herald & News newspapers being those of June 5 and 12, 1980, the date of the last publication being more than ten days prior to the date fixed for the beginning of the investigations and measurements of said stream system by the Director.

The Director sent by certified mail to each person, firm or corporation owning or being in possession of lands not included in the original Lost River Adjudication and, bordering on or having access to said stream or its tributaries, insofar as said claimants and owners and persons in possession could reasonably be ascertained, a notice similar to such published notice. Included was an explanatory statement and a blank form upon which the claimant or owner could prepare in writing his notice of intention to file a statement and proof of claim of his right to the use of the waters of Lost River and its tributaries.

Duly qualified assistants to the Director made examinations, surveys, and measurements of Lost River and its tributaries, and of the works diverting water therefrom, and surveys of the lands irrigated, and gathered such other data and information as were essential to the proper supplemental determination of the relative rights of the parties. The observations and measurements were reduced to writing and made a matter of record in his office. The Director had a set of maps prepared showing with substantial accuracy the location of all streams in the drainage basin, the location of each means of conveyance of appropriated water and the points of diversion thereof, and the number of acres of land being irrigated in each legal subdivision, or other use of water. Prints of these maps are on file and a part of the record herein.

The U.S. Department of Justice submitted Statement and Proof of Claim in the name of United States of America for: The U.S. Bureau of Reclamation, Department of Interior; Fremont National Forest, Department of Agriculture; and Winema National Forest, Department of Agriculture. The Statements and Proofs of Claim were not filed in the proceedings by order of the Director on December 18, 1986, as they were not accompanied by fees as required by ORS 539.030 and they were not complete. The Director also ordered that the forms be returned and an additional 90 days be allowed to submit any acceptable claim along with necessary fees.

was commenced before James W. Carver, Jr., an authorized assistant to the Water Resources Director and continued until disposed.

CONTEST NO. 1

Two statements and proofs of claim were filed in the names of Raymond Colahan and Kathleen Kamahaku claiming vested rights to storage and use of water from Wildhorse Creek in Klamath County, Oregon.

Proof No. 3 claims a vested right for storage of water from Wildhorse Creek in Ritter Reservoir within Sections 4 and 5 of Township 38 South, Range 11 East, WM, Klamath County, Oregon. Claimants claim a 2/3 interest in the waters stored in Ritter Reservoir which has a total capacity 293 acre-feet.

Proof No. 4 claims a vested right to use water stored in Ritter Reservoir and from the flow of Wildhorse Creek for irrigation of certain lands. The said proof states that beginning in 1903, and continuing to about the year of 1954, the water was used to irrigated a certain 15 acres in the NE1/4 SE1/4 and 29 acres in the SE1/4 SE1/4 of Section 1, Township 38 South, Range 11-1/2 East, and 25 acres in the NW1/4 SW1/4 of Section 6 of Township 38 South, Range 11 East, WM. The proof also states that in 1954, the place of use was changed to 2.4 acres in the NE1/4 NE1/4 and 16.8 acres in the SE1/4 NE1/4 of Section 1, Township 38 South, Range 11-1/2 East, and 20.6 acres in the NW1/4 NW1/4 and 38.0 acres in the SW1/4 NW1/4 of Section 6, Township 38 South, Range 11 East, WM.

A contest against the said claims of vested water rights was filed in the name of Ritter Ranch, Inc., by Reginald R. Davis of the law firm of Brandness, Brandness and Davis, Klamath Falls, Oregon. The contestant was represented by Reginald R. Davis, Attorney at Law. The claimants were represented by James C. Lynch, Attorney at Law, Lakeview, Oregon.

Subsequent to the physical change in place of use in 1954, water for irrigation of the described lands within the E1/2 NE1/4 of Section 1 and the W1/2 NW1/4 of Section 6 was pumped from the channel of Wildhorse Creek within the SW1/4 NW1/4 of said Section 6, at a point about two miles downstream from Ritter Reservoir. The pump, powered by an electrical motor, discharged the water into a pipeline and sprinkler system to be spread on the subject land.

The said pump was removed during the year of 1981, and the power service to the pumping site was disconnected. Subsequent to that, the pipeline and sprinkler system was replaced. The subject lands within the E1/2 NE1/4 of Section 1 and the W1/2 NW1/4 of Section 6 continued under irrigation, but not from Ritter Reservoir or Wildhorse Creek. The subject lands, along with other lands, came under irrigation by means of a center pivot irrigation system supplied with ground water from a well.

Since 1981, the claimants have not had in place a pump and distribution system

capable of diverting the waters available in Ritter Reservoir and/or the channel of Wildhorse Creek to beneficial use on the subject lands.

The record shows that from 1981 through 1987, there were two years that water was available from storage in Ritter Reservoir that could have been called for and used by the claimants on the subject lands. During the irrigation season of 1982, Ritter Reservoir was nearly full to its capacity of 293 acre-feet of water. Two-thirds of that stored water was subject to the call and use by the claimants. During the irrigation season of 1984, Ritter Reservoir was filled to approximately one-half of its full depth. At half-full depth, the stored water would total approximately 65 acre-feet. Two-thirds of that amount, or approximately 43 acre-feet of that stored water was subject to call and use by the claimants.

The record is clear that the claimants chose not to call for and use the waters available to them from storage in Ritter Reservoir on the subject lands.

There are two issues before the Director in this matter:

First, have the claimants abandoned or forfeited the claimed vested right for irrigation by failure to make beneficial use of available water for irrigation of the described lands within the E1/2 NE1/4 of said Section 1 and the W1/2 NW1/4 of said Section 6, within a specific period of years?

Second, was the claimed vested right for irrigation abandoned or forfeited by ceasing beneficial irrigation in 1954, on the described lands occupying the original place of use within the E1/2 SE1/4 of said Section 1 and the W1/2 SW1/4 of said Section 6 and, in lieu thereof, using water for beneficial irrigation of the described lands occupying the new place of use?

ORS 540.610(1) provides, "Beneficial use shall be the basis, the measure and the limit of all rights to the use of water in this state. Whenever the owner of a perfected and developed water right ceases or fails to use the water appropriated for a period of five successive years, the right to use shall cease, and the failure to use shall be conclusively presumed to be an abandonment of water right. Thereafter the water which was the subject of use under such water right shall revert to the public and become again the subject of appropriation in the manner provided by law, subject to existing priorities."

The claimants did not stand ready with a system of works to divert and apply available water from Ritter Reservoir or Wildhorse Creek during any of the years of 1982 through 1987. In the matter of Day v. Hill, 241 OR 507 (509) the Supreme Court of Oregon held: "[I]t is immaterial whether there was enough water in Walker Creek for the plaintiffs' use. If there had been enough water, plaintiffs had no way of diverting it onto their land." The issue before the court was a matter of forfeiture of a "perfected and developed" water right resulting from five successive years of nonuse, pursuant to ORS 540.610 to 540.650.

The matter now before the Water Resources Director pertains to claimed vested rights, not to "perfected and developed" rights. However, we believe the standard as stated by the court is applicable in this matter.

The claimed vested water rights as described by Proof No. 3 and Proof No. 4 have been abandoned pursuant to the provisions of ORS 540.610(1) and are hereby denied.

CONTEST NO. 2

Prior to the date and time set for the hearing on contest, the matter was settled by stipulation between the Contestant (United States Bureau of Reclamation) and Contestee (Circle Five Ranch, Inc., by Louis Randall, President), which stipulation is entered as evidence in this proceeding as follows:

THIS AGREEMENT is being made to settle a long standing water rights dispute between Louis Randall and the U.S. Bureau of Reclamation concerning water use in the Big and Little Squaw Flat Reservoir areas.

IT IS mutually understood that:

1. Louis Randall will remove the Dam at the Big Squaw Flat located in the NE1/4 SE1/4 of Section 6, Township 39 South, Range 15 East, W.M. The removal will be complete down to the original ground level and all control structures will also be removed prior to the 1989-1990 storage season. However, in the event that the dam is over-excavated, the right is reserved to place a gated structure in the channel so long as no part of the structure is above the original ground at the dam site. This will allow the draining of a dead storage pool in the Big Squaw Flat area at Louis Randall's convenience. Normal storage in the Big Squaw Flat Reservoir is approximately 500 acre-feet.
2. The Bureau of Reclamation will not protest Louis Randall's future application to raise the Little Squaw Flat Dam located in the SE1/4 NE1/4 of Section 4, Township 39 South, Range 15 East, W.M., to accommodate an additional storage of 150 acre-feet. The current storage in Little Squaw Flat Reservoir is 440 acre-feet. The additional 150 acre-feet would bring the storage to an agreeable amount of 590 acre-feet for continued future use.
3. The Bureau of Reclamation will not protest Louis Randall's application to construct a reservoir and dam located approximately one (1) mile Northeast of the Little Squaw Flat Dam. The reservoir is located in a natural depression in the SE1/4 SW1/4 of Section 34, Township 38 South, Range 15 East, W.M., and is presently considered dead storage. As a result, it will be necessary for Louis Randall to construct an outlet canal to make use of the stored water. This canal will divert water into the Big Squaw Flat area and then be returned to Long Branch Creek below. At the present time, the estimated dead storage is approximately 100 acre-feet. The dam will be constructed

of sufficient height to contain the present dead storage and an additional 50 acre-feet.

4. The Bureau of Reclamation will withdraw the Statement of Contest filed with the Water Resources Director of the State of Oregon on April 15, 1988, which contested the claims of Louis Randall to the use of the Squaw Flat and Little Squaw Flat Reservoirs. A copy of this Memorandum of Agreement will be filed with the Oregon Department of Water Resources.

5. Any action taken by the United States Department of Interior, Bureau of Reclamation, acting through its authorized representative, in settlement or resolution of the subject protest(s) or contest(s) is not in any way to be deemed a waiver of the right of the United States to have its water rights adjudicated only in proceedings which constitute a "suit" under the McCarran Agreement.

6. This agreement shall be binding upon and inure to the benefit of the parties hereto, their heirs, successors and assigns.

This agreement is dated the 16th day of March, 1989.

The rights to the use of water from unnamed creeks tributaries of Lost River, as claimed by the Contestee in his Statements and Proofs of Claim No. 1 and No. 2, are more particularly determined in Finding #42 and #43 and set out in the tabulation of water rights under Finding #72 herein.

On the 16th day of February 1989, the Director served notice of Contest No. 3 by certified mail on each of the parties to the contest and on their respective counsel. The date fixed for the hearing was not less than 30 days and not more than 60 days from the date of notice of the hearing served on said parties and their counsel.

Due proof of the various notices by certified mail as stated has been made and filed as a part of the record herein.

CONTEST NO. 3

Prior to the date and time set for the hearing on contest, the matter was settled by stipulation between the Contestant (United States Bureau of Reclamation) and Contestee (E.L. and Mildred Garrett), which stipulation is entered as evidence in this proceeding as follows:

THIS AGREEMENT is being made to settle a long standing water rights dispute between E.L. and Mildred Garrett and the U.S. Bureau of Reclamation concerning water use in the Pitt and Arkansas Reservoir areas.

IT IS mutually understood that:

1. E.L. and Mildred Garrett will remove the dam at the Pitt Reservoir located in the SW1/4 NW1/4 of Section 4, Township 39 South, Range 16 East, W.M. The removal will be complete down to the original ground level and all control structures will be removed. Work to accomplish

the above will be completed prior to the 1989-1990 storage season.

2. The Bureau of Reclamation will not object to the continued use by E.L. and Mildred Garrett to store a maximum of 122 acre-feet in Arkansas Reservoir.

3. The Bureau of Reclamation will withdraw the Statement of Contest filed with the Water Resources Director of the State of Oregon on April 15, 1988, which contested the claims of E.L. and Mildred Garrett to the use of the Arkansas and Pitt Reservoirs. A copy of this Memorandum of Agreement will be filed with the Oregon Water Resources Department.

4. Any action taken by the United States Department of Interior, Bureau of Reclamation, acting through its authorized representative, in settlement or resolution of the subject protest(s) or contest(s), is not in any way to be deemed a waiver of the right of the United States to have its water rights adjudicated only in proceedings which constitute a "suit" under the McCarran Amendment.

5. This agreement shall be binding upon and inure to the benefit of the parties hereto, their heirs, successors and assigns.

This agreement is dated the 20th day of March, 1989.

The right to the use of water from Lapham Creek, Pitt Lake Reservoir and Arkansas Reservoir, as claimed by the Contestee in their Statement and Proof of Claim No. 7, are more particularly determined in Finding #48 and set out in the tabulation of water rights under Finding #72 herein.

On the 16th day of February 1989, the Director served notice of Contest No. 4 by certified mail on each of the parties to the contest and on their respective counsel. The date fixed for the hearing was not less than 30 days and not more than 60 days from the date of notice of the hearing served on said parties and their counsel.

CONTEST NO. 4

Prior to the date and time set for the hearing on contest, the matter was settled by stipulation between the Contestant (United States Bureau of Reclamation) and Contestee (J. Boyd Taylor, Representing the Estate of Josephine Taylor), which stipulation is entered as evidence in this proceeding as follows:

THIS AGREEMENT is being made to settle a long standing water rights dispute between the J. Boyd Taylor (Estate of Josephine Taylor) hereinafter called Estate, and the U.S. Bureau of Reclamation concerning water use in the Strawberry and Oxbow Reservoir areas.

IT IS mutually understood that:

1. The Estate will modify the spillway at Strawberry Dam to bypass all storage in excess of 1114 acre-feet. Said spillway and dam are located in the SE1/4 SE1/4 of Section 8, Township 40 South, Range 16 East, W.M. The modification to the spillway will be completed prior to the 1989-1990 storage season.
2. The Estate will be allowed to store additional water in the Strawberry Reservoir whenever the storage in Gerber Reservoir is above 58,000 acre-feet on the 1st of March. Under this condition, Strawberry Reservoir storage shall be allowed to increase to 1880 acre-feet. The Estate will request, in writing from the Bureau, storage information and the Bureau will grant permission, in writing, prior to the increasing of storage levels above 1114 acre-feet in Strawberry Reservoir.
3. The Bureau of Reclamation will not object to the Estate continuing to operate Oxbow Reservoir for water control and storage to its present capacity of 309 acre-feet.
4. The Bureau of Reclamation will withdraw the Statement of Contest filed with the Water Resources Director of the State of Oregon on April 15, 1988, which contested the claims of the Josephine Taylor Estate to the use of the Strawberry and Oxbow Reservoirs. A copy of this Memorandum of Agreement will be filed with the Oregon Water Resources Department.
5. Any action taken by the United States Department of Interior, Bureau of Reclamation, acting through its authorized representative, in settlement or resolution of the subject protest(s) or contest(s), is not in any way to be deemed a waiver of the right of the United States to have its water rights adjudicated only in proceedings which constitute a "suit" under the McCarran Agreement.
6. This agreement shall be binding upon and inure to the benefit of the parties hereto, their heirs, successors and assigns.

This agreement is dated the 21st day of March, 1989.

The rights to the water from Strawberry Reservoir, Strawberry Creek, Barnes Valley Creek, unnamed draw and Oxbow Reservoir, as claimed by the Contestee in his Statements and Proofs of Claim No. 20 and No. 21, are more particularly determined in Finding #61 and #62 and set out in the tabulation of water rights under Finding #72 herein.

A letter written by R.H. Rogers, Engineer, dated June 15, 1937 relates, "... the remains of a smaller dam now about four feet high and five feet wide and built about 15 years ago..." (1920+). A deposition of Harry H. Howard dated June 30, 1961 relates, question: "Was the Little Squaw Flat Reservoir in there?" (fall of 1902) Answer: "I don't think it was."

It appears that any claimed right to store or to the use of stored water in Little Squaw Flat Reservoir, other than described in Water Right Certificate #14355 and Certificate #14398, should be and hereby is DENIED. That the claimant's right to store and the use of the stored water in Little Squaw Flat Reservoir shall be as set out and defined in Certificate #14355 and Certificate #14398.

Water is diverted by a dam across the unnamed creek, downstream from Little Squaw Flat Reservoir, that runs through Little Squaw Flat. The dam stops the flow of water and causes the meadow upstream to be irrigated by overflow and sub-irrigation from the channel. The land irrigated is a natural meadow used for livestock pasture.

Following the open inspection of evidence, a drafting error was discovered on the map showing Little Squaw Flat. The map error showed 11.7 acres of irrigation within the SW1/4 SE1/4, Section 4, T39S R15E W.M. The correct acreage of irrigation within the SW1/4 SE1/4, Section 4, T39S R15E W.M. is 21.7. The map has been changed to show the 21.7 acres.

Claimant's Statement and Proof of Claim was filed with the Water Resources Department on June 17, 1982. The fees required under ORS 539.080 were paid. A letter dated February 17, 1988, and an amendment to the Statement and Proof of Claim was received by the Water Resources Department on February 19, 1988. Fees were paid to cover the additional water use described in the amendment. The letter included a written protest as to the claimant being required to pay the fees.

Mr. Marlin Wilson is a member of the Klamath Indian Tribe. The property involved in this claim is within the boundaries of the terminated Klamath Indian Reservation.

Mr. Wilson bought a portion of the property from his uncle, Edison Tupper (deceased), a Klamath Indian. Mr. Tupper received a fee simple patent to the property from the United States. The land description is Lot 1, Lot 2 and SE1/4 NE1/4, Section 6, T37S R11-1/2E W.M.

Mr. Wilson included another parcel of land in his claim. The description is: W1/2 W1/2 SW1/4, Section 33, T36S R10E, W.M. and Lot 5, Lot 8, Lot 9, N1/2 Lot 6, N1/2 Lot 7 and N1/2 Lot 10 all Section 5, T37S R11-1/2E W.M. and a portion of the NW1/4 SW1/4 NW1/4, Section 4 and 6.5 acres being a portion of the S1/2 Lot 6 and the NE1/4 SE1/4 NE1/4, Section 5, T37S R11-1/2E (See Attachment 2 page 1 of statement and proof of claim for metes and bounds description). It appears that all of this parcel, with the exception of the 6.5 acre tract, was allotted to a Klamath Indian. Title to the 6.5

acre tract was acquired by Mr. Wilson through an Interchange Deed with the United States of America, Department of Agriculture, Forest Service. It appears Mr. Wilson transferred title of a portion of the property in Section 5 to the U.S. Forest Service. A copy of a map showing "Wilson to U.S. Forest Service 6.4 acres" and "U.S. Forest Service to Wilson 6.5 acres" was submitted as evidence with Mr. Wilson's claim. A copy of a "Small Tract Application" signed by Mr. Wilson proposing to transfer the 6.4 acres for 6.5 acres of U.S. Forest Service land was submitted as evidence with Mr. Wilson's claim. A copy of a preliminary title insurance report covering Mr. Wilson's 6.4 acres was submitted as evidence with Mr. Wilson's claim. It appears that Mr. Wilson transferred title to 6.4 acres located on the west side of Lot 9 and 10, Section 5, T37S, R11-1/2E, which is the westerly portion of "Parcel 2" as described by letter dated April 21, 1989, to the Water Resources Department from Sande Schmidt, Attorney, representative of Native American Program, Oregon Legal Services Corporation, Mr. Wilson's representative.

It is recognized that Mr. Marlin Wilson possesses Federal Indian Reserved Water Rights. It is the intention of the Water Resources Department to quantify those rights in this proceeding.

Mr. Wilson's claim to a water right of "time immemorial for hunting, fishing and gathering purposes" along with his claim of "a right to use water for protection and maintenance of hunting, fish and gathering rights" is DENIED. The United States Court of Appeals, Ninth Circuit, in United States vs. Adair decided November 15, 1983, refers numerous times to the "Klamath Tribe" or "Tribe" water rights for hunting and fishing. The water rights for hunting and fishing belong to the Tribe. In a letter dated April 21, 1989, by Sande Schmidt, agent for Marlin and Rosa Wilson, she says, "Since the law is now clear that the Klamath Tribe can assert and protect this water right, there is no need for the Wilsons to pursue the protective claim filed in 1982." The question of hunting, fishing and gathering rights is not an issue in this determination.

Mr. Wilson's claim to a water right for future mining is DENIED. A water right for future mining was not reserved by the Federal Government to the Klamath Tribe when the Klamath Indian Reservation was created.

#### Domestic

Mr. Wilson has a cabin on his property. It is located within the following legal description:

T. 37 S., R. 11-1/2 E., W.M.

Sections 4 and 5; portion of the NW1/4 SW1/4 NW1/4 of Section 4 and portion of the S1/2 of Lot 6 and the NE1/4 SE1/4 NE1/4 of Section 5 described as follows:

Beginning at the northeast corner of the S1/2 Government Lot 6, Section 5, T. 37 S., R. 11-1/2 E., W.M., thence South 00 degrees 12' 48" West 662.08 feet to the N1/16 corner of said Section 5; thence South 00 degrees 19' 19" East 176.61 feet; thence South 02 degrees 54' 02" East 111.41 feet; thence South 18 degrees 17' 12" West 233.71 feet; thence South 89 degrees 54' 11" West 131.43 feet; thence North 71 degrees 28' 32" West 213.27 feet to a point on the easterly right-of-way of the Oregon, California, and Eastern Railroad; thence northeasterly along the easterly right-of-way line of said Oregon,

California, and Eastern Railroad to a point on the north line of the S1/2 of Government Lot 6; thence South 89 degrees 30' 38" East 176.75 feet to the point of beginning.

Title to this property was acquired through a deed interchange agreement. The evidence submitted on title chain is incomplete but it appears that Mr. Wilson traded 6.4 acres of his deeded property for the above described property. Mr. Wilson uses water from an unnamed stream in the cabin. A bucket is used to carry water from the stream to the cabin for domestic use within the cabin.

This claimed right is limited to 0.001 cfs, up to 1/2 acre-foot per year for domestic use within the cabin from the unnamed stream with a priority date of October 14, 1864. Claimant's rights are listed in the tabulation of water rights in Finding #72.

#### Stock Watering

In the past, Mr. Wilson has used his property for stock grazing. He has indicated he runs up to 50 head of cattle. There are two sources of surface water on his parcel in Section 6 and one source of surface water on his parcel in Section 5, all of which he uses for stock watering.

Cruikshank Creek, tributary to Buck Creek, is used for stock watering within the SE1/4 NE1/4, Section 6. There is a dam in the channel used as the diversion point. This claimed right is limited to 0.01 cfs for stock watering from Cruikshank Creek with a priority date of October 14, 1864.

Calico Spring Creek, tributary to Buck Creek, is used for stock watering within the SE1/4 NE1/4, Section 6. There is a dam in the channel used as the diversion point. The dam forms a stock pond which stores water. This claimed right is limited to 0.4 acre-foot stored water and 0.01 cfs for stock watering from Calico Spring Creek with a priority date of October 14, 1864.

An unnamed stream, tributary to Buck Creek, is used for stock watering within Lot 5, Lot 6 and the SE1/4 NE1/4, all in Section 5. This use is coincident with the irrigation use and is included with that part of the claim.

Claimant's rights are listed in the tabulation of water rights in Finding #72.

#### Irrigation

There is a total of 8.8 acres of Mr. Wilson's property, within the NE1/4, Section 5, east of the O.C. & E. Railroad right-of-way that is irrigated. An unnamed stream crosses his property and spreader dams or dikes have been built to slow the water flow, flood the meadow grasses and irrigate the pasture. The livestock on this property go to the channel to water. The stock watering is coincident with the irrigation. This claimed right is limited to 0.11 cfs for irrigation and stock watering from the unnamed stream with a priority date of October 14, 1864. Claimant's rights are listed in the tabulation of water rights in Finding #72.



Reserved Water Rights Claim

[Practicably Irrigable Acreage, (PIA)]

The original Statement and Proof of Claim filed by Mr. Wilson's agent on June 17, 1982 listed 30 acres within the SE1/4 NE1/4, Section 6, T37S, R11-1/2E as practicably irrigable acres (PIA). An amendment was filed on February 19, 1988 adding 15 practicably irrigable acres to Mr. Wilson's claim. The location being 8 acres within the NE1/4 NE1/4 and 7 acres within the SE1/4 NE1/4, both in Section 5, T37S, R11-1/2E. On April 21, 1989, additional evidence was submitted to the Water Resources Department which included Attachment J RESERVED RIGHT WATER CLAIM WILSON PROPERTY. This PIA report was prepared by Ron Bliesner of Keller-Bliesner Engineering of Logan, Utah.

It appears the report is preliminary and a review raises questions about its conclusiveness. It is possible following a field inspection of the Wilson property by the engineer that the following problems will be remedied.

The source of water suggested as being the best is Cruikshank Creek. This is based on one discharge measurement made during an above average water year, 1982, as shown by published hydrological data. Evidence gathered in this proceeding during the hearing of contest by Ritter vs. Colohan also shows that year as an above average water year. During the field inspection of the Wilson property by the Adjudication Field Supervisor, Mr. Wilson said that the creek usually dries up during the summer. It is very likely that any proposed irrigation system will require stored water to have an adequate amount of water available throughout the irrigation season.

It is suggested that Christmas trees would be the crop produced. Christmas tree production is not compatible with livestock production. Land put into Christmas trees would be lost to livestock grazing and would diminish the herd size.

The Christmas Tree Budget Summary suggests the varieties of trees produced would be Douglas Fir, White Fir and Scotch Pine. The production costs listed appear to be low, the market value appears to be high, the interest rate appears to be low and the ability to harvest at this site was not addressed. This property is at about 4600' elevation which makes weather and road conditions subject to extremes at times. The area to be planted shown on the accompanying map is west of the O.C. & E Railroad right-of-way and at the present time is inaccessible to large trucks. Construction of an access crossing and road would be necessary but was not included in the budget summary. The area east of the O.C. & E. Railroad right-of-way is included in the irrigated pasture with the unnamed stream as the source.

It is recommended this claimed right be DENIED.
