By letter of January 18, 1984, Tumalo Irrigation District protested the above-referenced application of the City of Bend for a permit to appropriate water from Tumalo Creek. Subsequent to the submission of the protest, representatives of Tumalo Irrigation District and the City of Bend entered into discussions to resolve any differences over the application that they might have. As a result of those discussions, the City of Bend and Tumalo Irrigation District have agreed that the inclusion of three specific conditions in a permit issued to the City of Bend pursuant to the application will satisfy the objections of Tumalo Irrigation District to the application and are acceptable conditions to the City of Bend.

Accordingly, Tumalo Irrigation District hereby withdraws its protest to Application No. 67983 on condition that the following three conditions are included in the permit issued pursuant to Application No. 67983, and the City of Bend hereby consents to the inclusion of those conditions in the permit issued pursuant to Application No. 67983:

22 The City of Bend shall by December 31, 1987, install 23 flow meters on the transmission mains at the intake. Meters 24 shall be of the following type 14-inch equivalent: or 25 mcCrometer, Model MW500.
