WARRANTY DEED

DONALD I. BEHRENDS, also known as DONALD BEHRENDS, and SHIRLEY BEHRENDS, husband and wife, hereinafter called Grantors, convey to CLAUDE W. PILCHER and GARNET F. PILCHER, husband and wife, as tenants by the entirety, all that real property situated in the County of Polk, State of Oregon, described as follows:
