Beginning at the Southeast corner of the Donation Land Claim No. 41, Township 25 South, Range 6 West, Willamette Meridian, Douglas County, Oregon, thence North $0^{\circ} 22'$ East along the East side of said Claim, 39 chains to the middle of Calapooia River; thence along center line of the channel of same North $45^{\circ} 50'$ West 3.80 chains and North $34^{\circ} 45'$ West 3.95 chains; thence leaving river West 26 chains to the center line of same; thence along same South $7^{\circ} 30'$ West 7.45 chains; south $53^{\circ} 15'$ West 4.45 chains; North 88° West 4.50 chains, North $48^{\circ} 45'$ West 7.05 chains; North 59° West 15.50 chains, South $72^{\circ} 45'$ West 3.15 chains, and South $30^{\circ} 15'$ West 1.30 chains; thence South 2.40 chains to a post on the left bank from which a ash 15 inches in diameter bears North $43-1/2^{\circ}$ West 30 links; thence South 13.50 chains to a quarter section corner between Sections 30 and 31, Township 25 South, Range 6 West Willamette Meridian, thence South $89^{\circ} 41'$ East 14.63 chains; thence South 29.54 chains to a sandstone 5 inches x 6 inches x 14 inches on the North line of Claim No. 40, thence East along said North line 47.71 chains to the place of beginning.
