THIS ORDER ISSUED TO

DILLON IRRIGATION COMPANY PO BOX 398 ECHO OR 97826

confirms the right to use the waters of UMATILLA RIVER, a tributary of the COLUMBIA RIVER for IRRIGATION, LIVESTOCK, AND DOMESTIC OF 753.4 ACRES

This right was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County. The decree is of record at Salem, in the Order Record of the Water Resources Director in Volume 3, at Page127. The date of priority is NOVEMBER 17, 1897 and 1907.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 9.42 CUBIC FEET PER SECOND (CFS); BEING 4.54 CFS WITH A PRIORITY DATE OF 1897 AND 4.875 CFS WITH A PRIORITY DATE OF 1907 (subject to the provisions of the UMTILLA RIVER DECREE, Paragraph 33).

The right to the use of water is restricted to beneficial use at the place of use described, and is subject all other conditions and limitations contained in the Umatilla River Decree Volume3, Page 127-251 and any related decree.

The quantity of water diverted at the new point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion described as follows:

The water user shall ensure the existing measurement device is maintained and operated and shall make sure improvements as may be required by the Department. If in the judgement of the Watermaster a different type of measureing device is needed an alternate measuring device may be required. The Western Land Canal NR Echo gaging station on the Umatilla River (Station number 14030500) is the current measuring point for this right.

The water user shall allow the Watermaster access to the meter or measuring device provided however, where the meter or measuring device is located within a private structure, the Watermaster shall request access upon reasonable notice.

The water user shall operate and maintain an approved fish screen at the new point of diversion. If Oregon Deprtment of Fish and Wildlife (ODFW) determine the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that Oregon Water Resources Department (OWRD) regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

This order is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered August 9, 2018, at Special Order Volume 109, Page 54, approving Transfer Application T-11648, affecting a portion of Umatilla Decree, State record of Water Rights.
