ORDER APPROVING A CHANGE IN POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7000 submitted by

CLYDE V. AND WANDA M. WARD

The right to be modified, as evidenced by a portion of Certificate 35979, was perfected under Permit 30570 with a date of priority of JUNE 17, 1965. The right allows the use of the COAST FORK WILLAMETTE RIVER, a tributary of the WILLAMETTE RIVER, for IRRIGATION OF 6.4 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.08 cubic foot per second, if available at the authorized point of diversion: SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within MORSS DLC 39, SECTION 12. T.19S., R.3W., W.M., 480 FEET NORTH AND 880 FEET WEST FROM SE CORNER, MORSS DLC 39, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

NW¼ SW¼ 2.2 ACRES
as projected within BRADSHAW DLC 55
SECTION 7
TOWNSHIP 19 SOUTH, RANGE 2 WEST W.M.

NE¼ SE¼ 4.2 ACRES
as projected within MORSS DLC 39
SECTION 12
TOWNSHIP 19 SOUTH, RANGE 3 WEST W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described


The applicant proposes to CHANGE THE POINT OF DIVERSION to: NE¼ SE¼, as projected within MORSS DLC 39, SECTION 12, T.19S., R.3W., W.M., 809 FEET NORTH AND 580 FEET WEST FROM SE CORNER, MORSS DLC 39

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1997.
2. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.
3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Certificate 35979 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
