Background

1. On November 15, 2000, Special Order Volume 54, Pages 826-834, a DETERMINATION AND ORDER APPROVING ALLOCATION AND ASSIGNMENT OF CONSERVED WATER (CW-9) was issued involving Tumalo Irrigation District's (TID) Certificates 74146, 74148 and 76106. On April 18, 2005, Special Order Volume 64, Pages 157-158, an ORDER FINALIZING THE ALLOCATION AND ASSIGNMENT OF CONSERVED under CW-9 was issued. This finding of fact clarifies the assignment of the conserved water under Certificates 74146 (primary irrigation) and 74148 (supplemental irrigation) to the place of use originally described under certificate 76106.
 - a. Consistent with these orders, the applicant's share of conserved water (11.3 cfs with a priority date of September 1900) under Certificate 74146¹ was assigned to serve

the 790.6 acres originally associated with Certificate 76106. Consistent with the order, lands formerly under Certificate 76106 assigned to Certificate 74146 (790.6 acres) have a priority date of September 1900 for primary irrigation.

- b. When the Department determines it is necessary for record keeping, it will issue a single superseding certificate for Certificate 74146. The superseding certificate will include both the place of use originally under Certificate 74146, and the place of use (790.6 acres) formerly under Certificate 76106 now assigned to Certificate 74146, as modified by any transfers, including Transfers T-9303, T-9593, T-10052, T-10759, T-10975, T-11167, and T-11329, completed pursuant to ORS 540.580.
- c. Also consistent with these orders, Certificate 76106 was cancelled with the issuance of confirming water right Certificate 81332 for the use of the waters of Tumalo Creek for instream use with priority date December 8, 1961, and the issuance of diminishment remaining right Certificate 88894 for use of the water of Upper Tumalo Reservoir for supplemental uses. Certificate 81332 was issued to the State of Oregon in exchange for TID receiving the State of Oregon's portion of conserved water under Certificate 74148.
- d. Thus, consistent with these orders, the entirety of the conserved water under Certificate 74148 (3,746 ac-ft) became the applicant's portion for supplemental irrigation under the same Certificate 74148. The conserved portion of water was assigned to serve the place of use (790.6 acres) described under Certificate 76106 for supplemental irrigation with the April 7, 1911 priority date.
- e. When the Department determines it is necessary for record keeping, it will issue a single superseding certificate for Certificate 74148 for supplemental irrigation. The superseding certificate will include both the place of use originally under Certificate 74148, and the place of use for the 790.6 acres as had been described in Certificate 76106, as modified by any transfers, including Transfers T-9303, T-9593, T-10052, T-10759, T-10975, T-11167, and T-11329, completed pursuant to ORS 540.580.

Findings of Fact

1. The following transfer final orders were issued after the issuance date, being April 18, 2005, of the ORDER FINALIZING THE ALLOCATION AND ASSIGNMENT OF CONSERVED under CW-9, referenced in Background Item #1 for Transfers T-9303, T-9593, T-10052, T-10759, T-10975, T-11167, and T-11329:

 - b. Special Order Volume 65, Pages 367-375, on July 13, 2005, approving T-9593;
 - c. Special Order Volume 68, Pages 216-223, on April 7, 2006, approving T-10052
 - d. Special Order Volume 77, Pages 372-383, on March 24, 2009, approving T-10759;

- e. Special Order Volume 81, Pages 1026-1035, on October 4, 2010, approving T-10975;
 - f. Special Order Volume 83, Pages 410-417, on January 28, 2011, approving T-11167;
 - g. Special Order Volume 87, Page 884, on February 28, 2012, approving T-11329 as corrected by Special Order Volume 87, Page 844, on June 19, 2012.
2. Transfers T-9303, T-9593, T-10052, T-10759, T-10975, T-11167, T-11329 were issued without including place of use changes to Certificate 74148 as affected by Special Order Volume 64, Pages 157-258 (place of use formerly under 76106). This correcting order is issued to correct the omission of these place of use changes in the original final orders listed in Finding of Fact #1 and supplements those orders.
 3. All lands under Certificate 74148 as affected by Special Order Volume 64, Pages 157-258 (place of use formerly under 76106) which were omitted in the original transfer orders are layered with places of use identical to lands under Certificate 74146² (formerly 76106) for primary irrigation, and Certificates 74149 and 76520 for supplemental irrigation. Changes to these identical lands have been already approved³ and confirmed⁴ under Transfers T-9303, T-9593, T-10052, T-10759, T-10975, T-11167, and T-11329.
 4. The use, priority date, sources of water, and authorized points of diversion of Certificate 74148 under Transfers T-9303, T-9593, T-10052, T-10759, T-10975, T-11167, and T-11329 are as follows:

Use: Supplemental Irrigation

Priority Date: APRIL 7, 1911

Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of the following amounts measured at the point of diversion from the Deschutes River for each acre irrigated during the periods indicated below during the irrigation season of each year.

Apr 1 to May 1 and Oct 1 to Nov 1: 0.75 acre-feet

May 1 to May 15 and Sep 15 to Oct 1: 0.50 acre-feet

May 15 to Sep 15: 7.40 acre-feet

Further limited to a total diversion of not to exceed 35,000 acre-feet stored water only during any one irrigation season.

The proposed changes in places of use and corrections as shown in Findings of Facts # 6, 8, 10, 12, 14, 16, 18, 19, 20, 21, 22, 23, and 24, above, for Transfers T-9303, T-9593, T-10052, T-10759, T-10975, T-11167, T-11329 satisfy the requirements of ORS 540.574(3) and 540.585.

Now, therefore, it is ORDERED:

1. The final order approving T-9303, as recorded in Special Order Volume 65, Pages 376-381, is hereby corrected to approve the place of use change for 2.0 acres under Certificate 74148 for supplemental irrigation, as shown in Finding of Fact #6, above. All other provisions of Special Order Volume 65, Pages 376-381, remain in effect.

The final order approving T-9593, as recorded in Special Order Volume 65, Pages 367-375, is hereby corrected to approve the place of use change for 11.0 acres under Certificate 74148 for supplemental irrigation, as shown in Finding of Fact #8, above. All other provisions of Special Order Volume 65, Pages 367-375, remain in effect.
3. The final order approving T-10052, as recorded in Special Order Volume 68, Pages 216-223, is hereby corrected to approve the place of use change for 3.8 acres under Certificate 74148 for supplemental irrigation, as shown in Finding of Fact #10, above. All other provisions of Special Order Volume 68, Pages 216-223, remain in effect.
4. The final order approving T-10759, as recorded in Special Order Volume 77, Pages 372-383, is hereby corrected to approve the place of use change for 10.0 acres under Certificate 74148 for supplemental irrigation, as shown in Finding of Fact #12, above. All other provisions of Special Order Volume 77, Pages 372-383, remain in effect.
5. The final order approving T-10975, as recorded in Special Order Volume 81, Pages 1026-1035, is hereby corrected to approve the place of use change for 6.76 acres under Certificate 74148 for supplemental irrigation, as shown in Finding of Fact #14, and as shown in Finding of Facts #19 and 20. All other provisions of Special Order Volume 81, Pages 1026-1035, remain in effect.
6. The final order approving T-11167, as recorded in Special Order Volume 83, Pages 410-417, is hereby corrected to approve the place of use change for 8.8 acres under Certificate 74148 for supplemental irrigation, as shown in Finding of Fact #16, and as shown in Finding of Facts #21, 22, 23, and 24. All other provisions of Special Order Volume 83, Pages 410-417, remain in effect.

7. The final order approving T-11329, as recorded in Special Order Volume 87, Page 884, is hereby corrected to approve the place of use change for 2.76 acres under Certificate 74148 for supplemental irrigation, as shown in Finding of Fact #18, above. All other provisions of Special Order Volume 87, Page 884, as corrected by Special Order Volume 87, Page 844, remain in effect.
