FOR APPROVAL OF A CHANGE IN PLACE)
OF USE OF WATER)

On February 11, 1986, an application was filed in the office of the Water Resources Director by Hebb Family Management Trust for approval of a change in place of use of water from Deschutes River, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 51231, Volume 46, State Record of Water Right Certificates, in the name of North Unit Irrigation District, describes a right which includes the use of water from Deschutes River, for irrigation of 3.1 acres in NE 1/4 SW 1/4 and 9.2 acres in NW 1/4 SW 1/4, Section 17, Township 12 South, Range 13 East, WM, with a date of priority of February 28, 1913. Said lands have a supplemental right under Certificate 51232, with a date of priority of June 23, 1955.

Water for the said right is diverted through the North Unit Main Canal.

The applicant herein, owner of the lands above described, proposes to transfer the rights therefrom to a certain 12.3 acres in SE 1/4 SW 1/4, Section 17, Township 12 South, Range 13 East, WM.

Robert F. Main, Jr., Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

The lands involved herein are within the boundaries of North Unit Irrigation District and the Board of Directors of said District approved the proposed change in place of use at a regular meeting.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it is hereby ORDERED that the proposed change in place of use is approved, without loss of priority.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1987.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of complete application of water to beneficial use on the lands to which the water is transferred hereby, the change in place of use shall be considered perfected, and at a later date a certificate of water right shall be issued to North Unit Irrigation District confirming this and other changes within the District, and superseding Certificate 51231.

NOTE: Approval of a water right transfer application does not confirm the status of the right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

A party may file objections and exceptions to the Proposed Order with the Water Resources Commission. Such objections and exceptions must be filed within 45 days from the date of service (date of mailing) of the Proposed Order on the party. The Commission will provide opportunity for oral argument in support of written objections and exceptions. If no objections and exceptions are filed within the time allowed, the Proposed Order will automatically become the Final Order of the Commission.
