**ORDER APPROVING A CHANGE IN PLACE OF USE
IN AN IRRIGATION DISTRICT**

Pursuant to ORS 540.580, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, DISTRICT TRANSFER 8649 submitted by

EAST FORK IRRIGATION DISTRICT
P. O. BOX 162
ODELL, OREGON 97044.

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for HOOD RIVER COUNTY as evidenced by portions of Certificate 74642. The decree is recorded in the Order Record of the WATER RESOURCES DIRECTOR in Volume 17 at Page 333. The date of priority is NOVEMBER 25, 1895.

The right allows the use of EAST FORK HOOD RIVER, a tributary of the HOOD RIVER, for irrigation of 3.95 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.049 CUBIC FOOT PER SECOND, if available at the authorized point of diversion: NW 1/4 SW 1/4, SECTION 4, T 1 S, R 10 E, W.M.; 3750 FEET SOUTH AND 430 FEET EAST FROM THE NORTHWEST CORNER, SECTION 4, or its equivalent in case of rotation, measured at the point of diversion from the source.

The District requests to move the rights listed in Table A to the location listed in Table B.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.


THEREFORE, THESE CHANGES TO THE EXISTING DISTRICT WATER RIGHT MAY BE MADE SUBJECT TO THE FOLLOWING CONDITIONS:

1. The proposed changes shall be completed on or before October 1, 2002.
2. The former places of use shall no longer be irrigated as a part of these water rights.
3. Proof, to the satisfaction of the Director, that the changes approved by this order have been completed must be submitted by EAST FORK IRRIGATION DISTRICT on or before October 1, 2003.

Except as modified herein, all other conditions and restrictions of Certificate 74642 remain in effect.

When the Director determines that it is necessary, or to facilitate records keeping, new certificates will be issued to confirm all completed changes for which satisfactory proof has been made and to confirm that portion of the right not modified by this or any other order.
