ORDER APPROVING TEMPORARY CHANGES IN PLACE OF USE
AND AN ADDITIONAL POINT OF DIVERSION

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 9515 submitted by

The right to be modified, as evidenced by a PORTION of Certificate 654. The decree is recorded in the Order Record of the Water Resources Director in Volume 1, at Page 449. The dates of priority are 1873 FOR 18.0 ACRES and 1906 FOR 18.0 ACRES. The right allows the use of OCHOCO, VEAZIE AND LAWSON CREEKS, a tributary of the CROOKED RIVER, for IRRIGATION of 36.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.45 cubic foot per second, the total quantity being limited to four acre feet per acre during each year, if available at the

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order.

authorized point of diversion; SE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 29, T 14 S, R 18 E, W.M.; 2016 FEET EAST AND 1214 FEET NORTH FROM THE SW CORNER, SECTION 29, or its equivalent in case of rotation, measured at the point of diversion from the source.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

The applicant further proposes an additional point of diversion as follows:

SW¼ SE¼, T 14 S, R 18 E, W.M.; 2261 FEET WEST AND 1042 FEET, FROM THE SE CORNER, SECTION 31.


THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. These changes are temporary. These changes shall be effective upon issuance of this order.
2. The former place of use **shall not** be irrigated as part of this water right during the 2003, 2004, 2005, 2006 and 2007 irrigation seasons.
3. The use shall revert to the authorized place of use at the end of the 2007 irrigation season. In addition, the point of diversion will revert to the authorized point of diversion at the end of the 2007 irrigation season.
4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
5. Water used under Certificate 654 at the original location together with water used at the proposed location shall not exceed 0.45 cubic foot per second and 144 acre-feet during 2003, 2004, 2005, 2006 and 2007 irrigation seasons.

6. The quantity of water diverted at the new point of diversion, together with the quantity diverted at the authorized point of diversion, shall not exceed the quantity of water lawfully available from the original point of diversion. When the 1906 water right is being regulated off, the pivot must be off.

7. **PRIOR** to diverting of water at the new point of diversion, the water user **shall** install an in-line flow meter or other suitable device for measuring and recording the quantity of water used at **both** the authorized and the proposed points of diversion. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
