### **Findings of Fact**

- 1. Transfer Application T-11634, in the name of AMANDA A. STEELE, WILSON FAMILY RANCHES, LLC, JAMES F. PETERS, ROSS AND JACQUELYN FRITZ, AND JOHN R. AND SUZANNE M. KINDREE, was filed on July 2, 2013.
- 2. On November 5, 2018, the applicants submitted a written request asking that Transfer Application T-11634 be withdrawn.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
