### Authority

ORS 536.750 establishes the process in which a water right holder may submit a request to temporarily transfer the use, place of use or point of diversion of water in the event of a declaration of drought, without complying with the notice and waiting requirements under ORS 540.520. OAR Chapter 690, Division 019 implements the statutes and provides the Department's procedures and criteria for evaluating drought transfer applications.

# **Findings of Fact**

- 1. On July 12, 2013, TOM AND FAWN KERNS filed an application to temporarily change the place of use and the point of diversion under Certificates 45595 and 57606 for the remainder of the 2013 irrigation season or the term of the Governor's declared drought, whichever is shorter. The Department assigned the application number T-11640.
- 2. Notice of the application for transfer was published on July 16, 2013, pursuant to OAR 690-019-0055. No comments were filed in response to the notice.
- 3. The portion of the first right to be temporarily transferred is as follows:

**Certificate:** 45595 in the name of ANDY DELONG (confirmed by Powder River

Decree)

Use: IRRIGATION OF 20.0 ACRES

**Priority Date: 1868** 

Rate: 1/40 OF ONE CUBIC FOOT PER SECOND (CFS) PER ACRE (0.50 CFS)

**Source:** ROCK CREEK, tributary to the POWDER RIVER

# Temporary Transfer Review Criteria

- 10. Water has been used within the last five years according to the terms and conditions of the rights. There is no evidence available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 11. Diversion structures and ditches sufficient to use the full amount of water allowed under the existing rights are present.
- 12. The Governor issued an executive order on June 23, 2013, declaring a state of drought emergency in Baker County due to drought and extreme weather conditions, which is still in effect and the water right proposed for transfer is on lands included in the area covered by the drought order.
- 13. The proposed changes would not result in enlargement of the rights.
- 14. The proposed changes would not result in injury to other water rights. This finding is made through an abbreviated review recognizing that the transfer may be revoked under OAR 690-019-055(3) if the Department later finds that the transfer is causing injury to any existing water right.

#### **Conclusions of Law**

The temporary change in places of use and points of diversion proposed in Temporary Drought Transfer Application T-11640 are consistent with the requirements of ORS 536.750 and OAR 690-019-0055.

### Now, therefore, it is ORDERED:

- 1. The temporary changes in place of use and points of diversion proposed in Temporary Drought Transfer Application T-11460 are approved.
- 2. The former places of use **shall not** be irrigated as part of these water rights during the remainder of the 2013 irrigation season or until the end of the Governor's declared drought, whichever occurs first.
- 3. The approval of this temporary drought transfer may be revoked or modified if the Department finds the changes cause injury to any existing water right.
- 4. The use of water at the temporary places of use authorized by this transfer shall be in accordance with the terms and conditions of Certificates 45595 and 57606.

5.	The proposed places of use shall revert to the authorized places of use at the end of the 2013 irrigation season or the end of the Governor's declared drought, whichever occurs first.
