### FINDINGS OF FACTS

- 1. On February 28, 2005, the Department received an affidavit from Evers Family Living Trust, 3385 NW Highway 47, Forest Grove, Oregon, stating that they are the owner of lands and the water right appurtenant as evidenced by Certificate 13754, State Record of Water Right Certificates. The affidavit further states they have obtained a different source of water for primary irrigation of these lands and requests the water right be diminished from a right for primary irrigation to a right for supplemental irrigation of the lands.
- 2. The water right to be diminished is the right described by Certificate 13754, State Record of Water Right Certificates. The water right allows the use of not to exceed 0.33 cubic foot per second of water from Drainage Channel No. 7 and West Fork Dairy Creek, tributary to Dairy Creek, for irrigation of 25.7 acres. The priority date is January 5, 1939. The point of diversion is located in SE¼ SW¼, as projected within Ellison C. Johnson DLC 54, and NW¼ SE¼, Section 13, Township 1 North, Range 4 West, W. M..
- 3. The affidavit requests the following lands be diminished from primary irrigation to supplemental irrigation:

The quantity of water associate with the 21.9 acres equals 0.28 cubic foot per second.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

## CONCLUSIONS OF LAW

The Director of the Water Resources Department concludes that the portion of the right evidenced by Water Right Certificate 13754 as described in Findings of Fact #3 has been diminished from primary irrigation to supplemental irrigation

### **ORDER**

## IT IS HEREBY ORDERED:

- 1. Certificate 13754 is canceled.
- 2. The water right for irrigation of 21.9 acres as described by Certificate 13754 is diminished from a right for primary irrigation to a right for supplemental irrigation. The Department shall issue Certificate 81278, a new and superseding certificate, to confirm the diminution of the right
