O R D E RAPPROVING APPLICATION

On August 17, 1945, Mrs. E. E. Lehrmann, Route 4, Box 114, Grants Pass, Oregon, filed an application for the approval of a change in place of use of water from Little Savage Creek.

Certificate of water right recorded at page 8859, Volume 8, State Record of Water Right Certificates, was issued to Mrs. E. E. Lehrmann confirming a right to the use of the waters of Little Savage Creek for the irrigation of 1.7 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 30, Township 36 South, Range 4 West, W. M., with a date of priority of April 2, 1919.

The applicant herein, owner of the above-described land, proposes to transfer the 1.7 acre water right appurtenant thereto, without loss of date of priority, to 1.7 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 30, Township 36 South, Range 4 West, W. M.

Notice by publication, as provided by Section 116-606, O. C. L. A., was not given in connection with this application for the reason that said section provides that notice is not required in applications for only a change in place of use of water.

From a report submitted by Mr. Clinton A. Smith, Watermaster District No. 15, Medford, Oregon, it appears the proposed change in place of use of water may be made without injury to existing rights and, therefore, the application should be approved.


NOW, THEREFORE, it hereby is ORDERED that the proposed change

in place of use of water be and the same hereby is approved, and that the water right hereinbefore described as appurtenant to 1.7 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 30, Township 36 South, Range 4 West, W. M., having a date of priority of April 2, 1919, be severed therefrom and simultaneously and without loss of priority transferred to 1.7 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 30, Township 36 South, Range 4 West, W. M.

It is FURTHER ORDERED that complete application of water to beneficial use on the lands to which the water is transferred hereby, shall be made on or before October 1, 1946, or such extension of time as may be granted by the State Engineer for good cause shown.

It is FURTHER ORDERED that upon receipt of proof satisfactory to the State Engineer of the complete application of water to beneficial use upon the lands to which the water hereby is transferred, a certificate of water right shall be issued to Mrs. E. E. Lehrmann to the extent to which the water has been applied beneficially, and certificate of water right recorded at page 8859, Volume 8, State Record of Water Right Certificates, shall be cancelled.
