ORDER APPROVING A CHANGE IN POINTS OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7354 submitted by

FARMERS IRRIGATION DISTRICT
1985 COUNTRY CLUB ROAD
HOOD RIVER, OREGON 97031.

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for HOOD RIVER County as evidenced by Certificate 74300. The decree is recorded in the Order Record of the Water Resources Director in Volume 17, at Page 333. The date of priority is 1891 FOR DITCH CREEK AND PARKER SPRINGS AND 1899 FOR NORTH FORK GREEN POINT CREEK AND SPRING AT CAMP NO. 4.

The right allows the use of DITCH CREEK AND PARKER SPRINGS, NORTH FORK GREEN POINT CREEK, AND SPRING AT CAMP NO. 4, tributaries of HOOD RIVER, for IRRIGATION OF 56.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 2,410.2 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 6.25 CUBIC FEET PER SECOND (CFS), BEING 1.25 CFS FROM DITCH CREEK AND PARKER SPRINGS AND 5.0 CFS FROM NORTH FORK GREEN POINT CREEK AND SPRING AT CAMP NO. 4, if available at the authorized point of diversion: SE $\frac{1}{4}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 14, LOT 7 (NE $\frac{1}{4}$ SW $\frac{1}{4}$), SECTION 30, NW $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 32, T 2 N, R 9 E, WM; DITCH CREEK - 1820 FEET SOUTH AND 1270 FEET WEST FROM THE E $\frac{1}{4}$ CORNER, SECTION 14; PARKER SPRINGS - 1760 FEET NORTH AND 1480 FEET EAST FROM THE SW CORNER, SECTION 14; NORTH FORK GREEN POINT CREEK - 6940 FEET NORTH AND 14,820 FEET WEST; 6820 FEET NORTH AND 14,720 FEET WEST; SPRING AT CAMP NO. 4 - 4400 FEET NORTH AND 8100 FEET WEST; ALL THREE FROM THE SE CORNER OF THE SW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 34, T 2 N, R 9 E, WM, or its equivalent in

case of rotation, measured at the point of diversion from the source.

THIS RIGHT IS SUBJECT TO THE PROVISIONS OF FINDING NO. 15 WHICH PROVIDES THAT THE TOTAL QUANTITY DIVERTED FROM ALL SOURCES AT ANY ONE TIME UNDER THE RIGHTS ESTABLISHED FOR THE OLD HOOD RIVER IRRIGATION DISTRICT (UPPER DISTRICT) (ORIGINAL CERTIFICATES 46954, 46955, AND 46956) SHALL NOT EXCEED THE TOTAL OF THE SUM OF PRIMARY IRRIGATION ACRES MULTIPLIED BY 1/80 CUBIC FOOT PER SECOND PER ACRE (31.62 CUBIC FEET PER SECOND FOR 2529.4 ACRES) .

The amount of water used for irrigation, together with the amount secured under any other right for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 ACRE- FEET for each acre irrigated during the irrigation season of each year.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes to change the Ditch Creek and Spring At Camp No. 4 points of diversion only. The remaining points of diversion will not change. The new Ditch Creek and Spring At Camp No. 4 points of diversion are located:


SE¼ SE¼, SECTION 14, NW¼ NE¼, SECTION 32, T 2 N, R 9 E, WM; DITCH CREEK - 1900 FEET SOUTH AND 1080 FEET WEST FROM THE E¼ CORNER, SECTION 14; SPRING AT CAMP NO. 4 - 170 FEET SOUTH AND 800 FEET EAST FROM THE N¼ CORNER, SECTION 32.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1998.
2. The quantity of water diverted at the new points of diversion, together with that diverted at the old points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.
3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. When required by the Department, the water user or irrigation district shall operate and maintain the headgate and measuring device, as needed. The water user or irrigation district shall report total flow figures when requested by the Watermaster. The Watermaster may operate the headgate and monitor accuracy of the measuring device, as needed.
5. Water shall be acquired from the same surface water source as the original point of diversion.

Certificate 74300 is canceled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
