ORDER APPROVING A CHANGE IN PLACE OF USE
AND A CHANGE IN POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFERS 7405,7406 submitted by

The first right to be modified under Transfer Application 7405, as evidenced by a PORTION of Special Order Volume 49, Page 111, entered March 7, 1995, approving Transfer Application 6830, was perfected under Permit 12340 with a date of priority of AUGUST 31, 1936. The right allows the use of the NORTH UMPQUA RIVER, a tributary of the UMPQUA RIVER, for IRRIGATION OF 0.6 ACRE. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.008 cubic foot per second, if available at the original point of diversion: NE¼ SE¼, SECTION 15, T 26 S, R 4 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The second right to be modified under Transfer Application 7406, as evidenced by a PORTION of Special Order Volume 49, Page 109, entered March 7, 1995, approving Transfer Application 6829, was perfected under Permit 24629 with a date of priority of DECEMBER 17, 1956. The right allows the use of the NORTH UMPQUA

NOTICE: Under the provisions of OAR 137-004-0080, the applicant may petition for reconsideration of this order. The petition shall set forth specific grounds for reconsideration. The petition for reconsideration must be filed within 60 days after the date this order is served.

RIVER, a tributary of the UMPQUA RIVER, for IRRIGATION OF 1.4 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.018 cubic foot per second, if available at the original point of diversion: SE¼ NE¼, AS PROJECTED WITHIN HUNTLEY DLC 38, SECTION 15, T 26 S, R 4 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized point of diversion is located:

LOT 3 (NE¼ NW¼), SECTION 15, T 26 S, R 4 W, W.M.;
550 FEET SOUTH AND 620 FEET WEST FROM THE N¼ CORNER OF
SECTION 15.

The authorized place of use is located as follows:

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

290 FEET NORTH AND 30 FEET EAST OF THE WEST $\frac{1}{4}$ CORNER OF
SECTION 23.

Satisfactory proof of the completion of the changes approved by the orders of the Water Resources Director entered March 7, 1995, at Special Order Volume 49, Pages 109 and 111, approving Transfers 6829 and 6830, is confirmed as described above.

THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:


1. The proposed changes shall be completed on or before October 1, 2000.
2. The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.
3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same surface water source as the original points of diversion.
5. The former places of use shall no longer be irrigated as a part of these water rights.
6. The water user shall install and maintain a fish screen or fish by-pass device. The type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and Wildlife prior to beginning of construction and shall be installed under the supervision of the Department of Fish and Wildlife.

The water user may participate in the Oregon Department of Fish and Wildlife's cost sharing program for installation of screening and by-pass devices in accordance with ORS 540.525.

When satisfactory proof of the completed changes is received, new certificates confirming these water rights will be issued.
