The FIRST right to be modified, as evidenced by Certificate 27315, was perfected under Permit G-155 with a date of priority of MARCH 15, 1955. The right allows the use of A WELL, in the FORT ROCK BASIN, for IRRIGATION of 25.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.31 cubic foot per second, if available at the original well; SE½ NE½, SECTION 30, T 26 S, R 18 E, W.M.; 1 CHAIN NORTH AND 10 3/4 CHAINS WEST FROM THE E½ CORNER, SECTION 30, or its equivalent in case of rotation, measured at the well.

The authorized place of use is as follows:

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.015 cubic foot per second, if available at the original well; SE¼ SE¼, SECTION 2, T 28 S, R 16 E, W.M.; 160 FEET NORTH AND 60 FEET WEST FROM THE SE CORNER, SECTION 2, or its equivalent in case of rotation, measured at the well.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.13 cubic foot per second, if available at the original well; SW¼ SE¼, SECTION 21, T 27 S, R 17 E, W.M.; 80 FEET NORTH AND 40 FEET EAST FROM THE S¼ CORNER, SECTION 21, or its equivalent in case of rotation, measured at the well.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.19 cubic foot per second, if available at the original well; NE¼ SE¼, SECTION 29, T 27 S, R 17 E, W.M.; 2600 FEET EAST FROM THE C¼ CORNER, SECTION 29, or its equivalent in case of rotation, measured at the well.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed changes shall be completed on or before October 1, 2002.
- 2. The quantity of water diverted at the new points of appropriation (wells), together with the quantity diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available from the original points of appropriation.
- 3. When required by the Department the water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original points of appropriation.
- 5. The former places of use shall no longer be irrigated as part of these water rights.

Certificates 27315, 52364, 52631, 53347, 53453, 55097, 55098, 51770 and 53348 are canceled. New certificates will be issued to confirm those portions of the rights NOT involved in this transfer. When satisfactory proof of the completed changes is received, new certificates confirming these water rights will be issued.
