O R D E RApproving Application

On May 28, 1945, Otto Jaekel, Route 1, Walla Walla, Washington, filed an application for the approval of a change in points of diversion of water from West Branch of Crockett Branch of Little Walla Walla River.

In the adjudication proceedings determining the relative rights to the use of the waters of Walla Walla River and its tributaries a water right was recognized in the name of Otto Jaekel for the irrigation of 6 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 26, Township 6 North, Range 35 East, W. M., of which 5 acres have a date of priority of 1907 and 1 acre has a date of priority of 1900. Two ditches are used to convey the water for the irrigation of these lands, the points of diversion of said ditches being located as follows:

- (1) 809 feet south and 1100 feet west from the northeast corner of Section 35, Township 6 North, Range 35 East, W. M.,
- (2) 250 feet south and 1200 feet west from the northeast corner of Section 35, Township 6 North, Range 35 East, W. M.

The applicant herein proposes to change the present points of diversion downstream to a point to be located 700 feet north and 1295 feet west from the southeast corner of Section 26, Township 6 North, Range 35 East, W. M.

Notice by publication was given in the Milton Eagle, a newspaper of general circulation in Umatilla County, Oregon, for a period of at least three weeks and not less than one publication each week; namely, July 5, 12 and 19, 1945. The date fixed for the hearing in the

notice was not less than thirty days after the last publication.

No objections having been filed and it appearing that the proposed change in points of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in points of diversion of water from West Branch of Crockett Branch of Little Walla Walla River, to wit:

(1) from a point located 809 feet south and 1100 feet west from the northeast corner of Section 35, Township 6 North, Range 35 East, W. M., and

(2) from a point located 250 feet south and 1200 feet west from the northeast corner of Section 35, Township 6 North, Range 35 East, W. M.,

to a point to be located as follows:

700 feet north and 1295 feet west from the southeast

corner of Section 26, Township 6 North, Range 35 East, W. M., for the irrigation of 6 acres in the $SE\frac{1}{4}$ $SE\frac{1}{4}$, Section 26, Township 6 North, Range 35 East, W. M., of which 5 acres have a date of priority of 1907 and 1 acre has a date of priority of 1900, be and the same hereby is approved.
