**Authority**

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

**Findings of Fact**

**Background**

1. On April 12, 2010, COMMONWEALTH GROUP, LLC, (CHUCK STADELI, OWNER), filed an application to change the point of diversion and the place of use under Certificate 6088 and to change the point of diversion, place of use, and the character of use under Certificate 35993. The Department assigned the application number T-11061.
2. The portion of the first right to be transferred is as follows:

**Certificate:** 6088 in the name of D. MCCLEARY (perfected under Permit S-6384)  
**Use:** IRRIGATION of 22.0 ACRES  
**Priority Date:** JULY 1, 1924  
**Rate:** 0.28 CUBIC FOOT PER SECOND  
**Limit:** The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated.  
**Source:** ABIQUA CREEK, tributary to the PUDDING RIVER

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

**Use:** SAND AND GRAVEL WASHING

**Priority Date:** AUGUST 16, 1967

**Rate:** 0.61 CUBIC FOOT PER SECOND

**Limit:** The amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.61 cubic foot per second.

**Source:** ABIQUA CREEK, tributary to the PUDDING RIVER

10. The receiving landowner will be responsible for completing the changes and submitting a Claim of Beneficial Use after a Final Order is issued approving the transfer.
11. Notice of the application for transfer was published on April 20, 2010, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
12. A letter requesting additional information was issued on June 25, 2010. In response to the letter, a meeting was held July 23, 2010 at the Department with Steve Applegate (the agent for T-11061), and on July 26, 2010, the applicant submitted additional property information.
13. On August 25, 2010, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-11061 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of September 27, 2010, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
14. On September 16, 2010, the Department issued a Preliminary Determination proposing to approve Transfer Application T-11061 and mailed a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on September 21, 2010, and in the Silverton Appeal-Tribune

newspaper on October 13, 20 and 27, 2010, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

15. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screening and/or by-pass device is necessary at the new point of diversion to prevent fish from entering the diversion and/or safely transport fish back to the body of water from which the fish were diverted and that the diversion is not currently equipped with an appropriate fish screening and/or by-pass device. This diversion may be eligible for screening cost share funds.

***Transfer Review Criteria [OAR 690-380-4010(2)]***

16. Evidence was submitted with the application indicating that water has been used within the last five years according to the terms and conditions of the rights. There is also information suggesting that there may have been an extended period of time during which the right was not exercised. However, the information in the record is not sufficient to initiate cancellation proceedings under ORS 540.631.
17. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-11061.
18. The proposed changes would not result in enlargement of the rights, provided irrigation use is subject to the standard rate and duty and irrigation season conditions for this basin, being 1/80 cfs per acre, limited to 2.5 acre-feet per acre per year during the irrigation season.
19. The proposed changes would not result in injury to other water rights.

**Diminution of a Water Right**

20. The proposed place of use has an existing primary irrigation right evidenced by Certificate 40304 on 18.8 acres of the proposed place of use for the transferred rights. Pursuant to OAR 690-380-5120, when multiple primary irrigation rights exist on the same lands, the water right with the oldest priority date shall be considered the primary water right (unless the water user designates otherwise) and all other rights shall be diminished to supplemental.
21. On April 12, 2010, Eder Brothers, Inc., by Duane Eder, Partner (the landowner) submitted an affidavit for the partial diminution of water right Certificate 40304 from primary to supplemental irrigation, to become effective upon issuance of a Final Order approving Transfer Application T-11061. The portion of the right to be diminished is as follows:

**Certificate:** 40304 in the name of Robert W. Johnson (perfected under Permit S-33026)  
**Use:** IRRIGATION of 18.8 ACRES  
**Priority Date:** OCTOBER 27, 1967  
**Rate:** 0.24 CUBIC FOOT PER SECOND  
**Limit/Duty:** The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each

acre irrigated, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

**Source:** UNNAMED STREAM AND RESERVOIR, tributary to the WILLAMETTE RIVER

**Conclusions of Law**


The change in point of diversion, change in place of use, and change in character of use proposed in Transfer Application T-11061 are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000

**Now, therefore, it is ORDERED:**

1. The change in points of diversion, change in places of use, and change in character of use proposed in application T-11061 are approved.
2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 6088 and 35993 and any related decree, with the exception that sediment treatment will no longer be required under the Certificate 35993 right for the new irrigation use.
3. Water right certificates 6088 and 35993 are cancelled. A new certificate will be issued describing that portion of the Certificate 6088 right not affected by this transfer.
4. Certificate 40304 is cancelled and a new certificate will be issued to reflect the diminution of 18.8 acres to supplemental irrigation.
5. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original points of diversion.

6. Water use measurement conditions:
  - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of diversion.
  - b. The water user shall maintain the meters or measuring devices in good working order.
  - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
7. Prior to diverting water, the water user shall install a headgate to control and regulate the quantity of water diverted. The type and plans of the headgate must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department. The water user shall maintain the headgate as required by the Department.
8. Prior to diverting water, the water user shall install a fish screening and/or by-pass device, as appropriate, at the new point of diversion consistent with the Oregon Department of Fish and Wildlife's (ODFW) design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screen and/or by-pass device meets ODFW's criteria. Prior to submitting a Claim of Beneficial Use, the water user must obtain written approval from ODFW that the required screening and/or by-pass device was installed to the state's criteria. The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.
9. The former place of use of the transferred rights shall no longer receive water under the rights.
10. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2012**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
11. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
