Proof, satisfactory to the Water Resources Director, has been received that the authorized place of use has been irrigated within the terms and conditions of the permits.

THESE CHANGES TO EXISTING PERMITS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE PERMIT HOLDER:

- 1. The proposed changes shall be completed prior to October 1, 2000
- 2. The former places of use shall no longer be irrigated as a part of these permits.
- 3. All other terms and conditions of the permits shall remain the same.

Permits E-19, 407, 1706, and 2362 are amended as described herein. When satisfactory proof of the completed change is received, the land described herein may be included on the certificates confirming these water rights.
