**Findings of Fact**

1. On December 27, 2021, the Department issued an order approving Transfer Application T-12917, involving Certificates 35370, 40094, 40215, 35496, 35497, and 40094. The order was recorded at Special Order Volume 122, Pages 216-223.
2. On April 8, 2024, the Department identified a scrivener’s error, in the description of the change in point of appropriation under Certificate 40094, as follows:

The correct description of the change in point of appropriation under Certificate 40094 is reflected in the table below in bold:

4 S	2 W	WM	32	<b>NW NW</b>	<b>80</b>	RD POA 3 – 425 FEET SOUTH AND 180 FEET EAST FROM THE NW CORNER OF SECTION 32

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

3. On April 8, 2024, the Department identified a scrivener's error, in the description of the additional point of appropriation under Certificate 40094, as follows:


The correct description of the change in point of appropriation under Certificate 40094 is reflected in the table below in bold:
