FINAL ORDER

Authority

ORS 541.329 establishes the process by which a district may petition the Oregon Water Resources Commission for approval and acceptance of a district map identifying the location and use of the water rights within the district. ORS 541.327 authorizes the Walla Walla River Irrigation District to participate in the process described under ORS 541.325 to 541.331 within specified time limits.

Findings of Fact

1. Pursuant to ORS 541.329,

submitted a petition requesting approval and acceptance of district maps showing the location and use of water rights served by the Eastside Ditch within the boundary of Walla Walla River Irrigation District (WWRID). The petition was submitted to the Oregon Water Resources Department (Department) on April 14, 2008, and included the required fees.

2. A summary of water rights affected by the petition is displayed in Table 1.
3. WWRID petitioned the Department for modifications to 42 certificated water rights and two completed transfers. The water rights petitioned by WWRID authorize irrigation and supplemental irrigation of a total of 399.23 acres. A description of the location of the certificated water rights and completed transfers, modified by the petition is displayed in Table 2.
4. The petitioned water rights and completed transfers allow the use of the waters of the Walla Walla River and its tributaries, including ditches and canals for irrigation. The point of diversion for the petitioned rights remains unchanged and is located as identified by the subject water right certificates, with the exception of Certificates 12880, 13148 and 13151.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The location of the point of diversion for Certificates 12880, 13148 and 13151 is described to reflect the actual location and is as follows:

5. The certificates identified in Table 2 identify the source of water by a number of names including: Little Stream, a branch of Tualum River; McCoy Stream, a branch of Tualum River; McCoy Branch of Little Stream, a branch of Tualum River; Tualum River; Little Walla Walla River; East Branch of Crockett; East Branch of Little Stream, a branch of Tualum River; McCoy Stream or West Branch of Little Stream; and Tualum Branch of Walla Walla River. A review of the identified sources reveals that the source of water for all of these water rights is the Walla Walla River.
6. The certificates listed below authorize the use of water for domestic and stock purposes, in addition to irrigation. However, WWRID has submitted to the Department an affidavit stating that it does not deliver water for domestic purposes.

7. The location and use of the water rights *not* modified (remaining) by the petition are described in Table 4. The Department shall issue water right certificates totaling 15.74 acres, describing the water rights *not* modified by the petition.
8. Table 4 **also** describes the location and use of the water rights evidenced by Certificates 949, 6726, 12880, 12906, 13151 and 80892 petitioned to be canceled. Of the 399.23 acres appurtenant to the water rights petitioned, WWRID proposes cancellation of 6.71 acres of water rights.
9. The petitioner seeks certificates confirming the present place of use and types of use for the petitioned water rights. These rights authorize irrigation of 327.58 acres and 49.20 acres of supplemental irrigation. Additionally, some of these rights authorize stock watering. The petitioned changes for these rights are listed in Table 3.
10. Some of the petitioned acreage has other appurtenant primary water rights. These water right certificates and water use permits are shown in Table 5. The portions of these water rights that are appurtenant to acreage described in Table 3 will be diminished to supplemental. The petition includes requests to diminish portions of rights appurtenant to specific parcels. For those parcels with other appurtenant, layered, primary water rights, the right with the oldest priority date shall be considered the primary water right. All other water rights shall be diminished to supplemental water rights. The rights to be diminished are listed in Table 5 and total 9.95 acres.
10. Table 5 provides a description of a supplemental water right certificate and water use permits that are appurtenant to acreage described in Table 3. The listed certificate and water use permits authorize supplemental irrigation of more acreage than the primary acreage listed in

Table 3. The portion of these supplemental water rights exceeding the primary water rights will be cancelled. The petition includes requests to cancel portions of rights appurtenant to specific parcels. The portions of the water rights to be cancelled are listed in Table 5.

11. Transfer Application T-9437 was approved by the Water Resources Director in Special Order Volume 61, Page 216. The final order approved a change in place of use and point of diversion for Certificate 12916, changed the place of use for Certificate 49291, diminished a portion of Certificate 41017 and cancelled Certificate 47020. On October 15, 2007, the Department received a claim of beneficial use for Transfer Application T-9437.
12. The Department has determined that satisfactory proof of the changes authorized by the order approving Transfer Application T-9437 has been made. The Department will issue a new certificate confirming the changes in place of use and point of diversion approved by the order cited in Finding of Fact #11.
13. Transfer Application T-8855 was approved by the Water Resources Director in Special Order Volume 57, Page 884. The final order changed a point of appropriation and diminished to supplemental irrigation a 49.2 acre portion of Certificate 12242. On May 16, 2008, the Department received a claim of beneficial use for Transfer Application T-8855
14. The Department has determined that satisfactory proof of the changes authorized by the order approving Transfer Application T-8855 has been made. The Department will issue a new certificate confirming the changes in place of use and point of diversion approved by the order cited in Finding of Fact #13.
15. The Department reviewed the petition and maps submitted by WWRID. The Department's findings report is on file at the Department. Based on its review and report, the Department finds:
 - a. WWRID is a "district" as defined in ORS 541.325(1).
 - b. WWRID filed its notice with the Department prior to June 30, 2004.
 - c. WWRID filed its petition and maps before June 30, 2010.
 - d. The petition and map are in satisfactory form and are certified by WWRID.
 - e. The map is in an electronic format that meets the Department's standards.
 - f. The petition and map do not expand a water right beyond the total rights of record.
 - g. WWRID's petition contained the elements required by ORS 541.329(2).
 - h. WWRID's petition does not contain more acres than allowed in ORS 541.329(3).
 - i. The acreage petitioned is within the limits established by ORS 541.331(4).
 - j. WWRID provided notice to affected water users, as required by ORS 541.329(4).
 - k. The proposed changes would not result in injury to existing water rights.


Conclusions of Law

Walla Walla River Irrigation District's petition and maps comply with the requirements of ORS 541.325 to ORS 541.331.

Now, therefore, it is ORDERED:

1. The Department accepts and approves Walla Walla River Irrigation District's petition and maps of water rights.
2. The Department cancels certificates for the water rights listed in Table 2.
3. The Department cancels those portions of the certificates listed in Table 4 and shall issue new superseding certificates describing the remainder of the water rights.
4. The Department cancels the domestic portion of the certificates identified in Finding of Fact #6.
5. The Department shall issue certificates describing the remainder of the water rights as listed in Table 4.
6. The Department shall issue new confirming water right certificates conforming to the approved petition for irrigation of 318.58 acres and stock watering as listed in Table 3.
7. The water rights as identified in Table 5 are diminished to supplemental irrigation.
8. Absent receiving affidavits from the landowners to diminish to supplemental irrigation the conflicting rights identified in Table 5, the Department designates the water right with the senior priority date as primary for irrigation purposes. The Department designates the water right with the junior priority date for supplemental irrigation purposes. The Department shall issue water right certificates that reflect these designations.
9. The Department cancels a portion of Certificate 33111 and shall issue a certificate describing the remainder of the water right as listed in Table 5.
10. The Department confirms completion of the changes as authorized by the orders approving Transfers Applications T-9437 and T-8855 and shall issue confirming water right certificates. Transfer Application T-9437 shall also have a certificate issued for those acres mapped but outside the petitioned area.
11. The Department proposes to issue new certificates retaining the appropriate conditions, limitations, seasons of use, priority dates and rates for the rights.
12. Appendix A of this order references the new certificates issued as a result of the approval of the petition.
