ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein. TRANSFER 6777 submitted by

KENNETH H. COPPINGER 75235 COPPINGER LANE ECHO, OREGON 97826.

The right to be modified, as evidenced by Certificate 49733, was perfected under Permit G-6626 with a date of priority of DECEMBER 29, 1975. The right allows the use of COPPINGER WELLS #1 AND #2, within the STAGE GULCH BASIN, for IRRIGATION OF 714.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 7.55 cubic feet per second, with any deficiency in the available supply from Well #1 to be made up by appropriation from Well #2, or its equivalent in case of rotation, measured at the well.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The wells are located:

SW¼ NE¼, SE¼ NE¼, SECTION 24, T 3 N, R 29 E, W.M.; WELL #1 - 20 FEET NORTH AND 1570 FEET WEST; WELL #2 - 960 FEET NORTH AND 30 FEET WEST, BOTH FROM THE E¼, SECTION 24;

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to any reasonable rotation system ordered by the proper state officer.

The applicant proposes to ADD FIVE ADDITIONAL POINTS OF APPROPRIATION located:

SW¼ SW¼, SECTION 7, T 3 N, R 30 E, W.M.; HALE WELL #3 - 1220 FEET NORTH AND 40 FEET EAST FROM SW CORNER, SECTION 7;

SW¼ NW¼, SECTION 14, T 3 N, R 29 E, W.M.; HALE WELL #8 - 1320 FEET NORTH AND 1320 FEET WEST FROM THE CENTER OF SECTION 14;

NE% NE%, SECTION 23, T 3 N, R 30 E, W.M.; COPPINGER WELL #3 - 3960 FEET NORTH AND 1320 FEET WEST FROM THE SE CORNER, SECTION 23:

NE% SW%, SECTION 30, T 3 N, R 30 E, W.M.; BROGOITTI WELL #1 - 30 FEET SOUTH AND 640 FEET WEST FROM THE CENTER, SECTION 30; AND

SW¼ SW¼, SECTION 20, T 3 N, R 30 E, W.M.; BROGOITTI WELL #2 - 100 FEET NORTH AND 80 FEET EAST FROM THE SW CORNER, SECTION 20:

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 2004.
- 2. The quantity of water diverted at the new points of appropriation (wells), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original points of appropriation.

- 3. **Prior** to diverting water from the new points of appropriation (wells), the water user **shall** install an inline flow meter or other suitable device for measuring and recording the quantity of water used for all wells described in this order. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 49733 is canceled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
