ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

- The Department issued an order approving T-7856 on May 24, 2002. The order was recorded at Special Order Volume 56, Pages 399 to 402.
- Application T-7856 was filed on October 3, 1997 by the City of Joseph. The application was filed with the consent of the Boise Cascade Corp, the landowner from whom the city was negotiating purchase of the property and appurtenant water rights.
- The right affected by the transfer is as follows:

- 4. The application proposed to change the authorized point of appropriation and place of use. In addition, the application proposed to change the character of use to municipal use.
- 5. On April 26, 2000, the City of Joseph provided the Department written notification that the property and appurtenant water rights had been acquired by the Joseph Chamber of Commerce and requested that the rights be placed in the name of the Joseph Chamber of Commerce.
- 6. Application T-7856 involved changes in the character of use of the right from industrial use to municipal use. Pursuant to OAR Chapter 690, Division 300, the Joseph Chamber of Commerce is not a municipal corporation eligible to hold a municipal use right as requested in the transfer.
- 7. The April 26, 2000 letter indicating that the Chamber of Commerce had acquired the lands and requesting that the rights be placed in the Chamber's name constituted a modification of the application. Given that the modification could not be accommodated under the Department's rules and that the landowner had communicated disagreement with the transfer as originally proposed, the transfer could not be approved.
- 8. The order approving T-7856 was issued in error.

Now, therefore, it is ORDERED:

- 1. The order approving T-7856 as recorded Special Order Volume 56, Pages 399 to 402 is corrected and the application T-7856 is rejected.
- 2. A new certificate will be issued describing the water right involved in the transfer consistent with Certificate 55036.
