This order confirms the right to use the waters of EAST FORK HOOD RIVER, A TRIBUTARY OF HOOD RIVER, FOR INDUSTRIAL USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for HOOD RIVER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 17 at Page 333. The date of priority is NOVEMBER 25, 1895.

The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 0.135 CUBIC FOOT PER SECOND (cfs), or its equivalent in case of rotation, measured at the point of diversion from the source. The period of allowed use is restricted to the season April 15 to October 1 of each year and shall not exceed a total diversion of 32.4 acre-feet per season.

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
