ORDER

On November 4, 1976, Artemy Egoroff submitted an affidavit that he is the owner of a water right and the lands to which the right is appurtenant; that he has abandoned any and all interest in and to the said water right and request the same be canceled.

The water right in question is part of that evidenced by certificate recorded at Page 39024, Volume 31, State Record of Water Right Certificates, and is for the appropriation of not to exceed 0.07 cubic foot per second of water from a well, with a priority date of January 15, 1969, for the supplemental irrigation of 24.8 acres in SW½ SE½ of Section 20 and 4.2 acres in NW½ NE½ of Section 29, Township 5 South, Range 1 East, W.M.

That part of the water right evidenced by said certificate for the appropriation of not to exceed 0.31 cubic foot per second of water from the well for the supplemental irrigation of 15.6 acres in SE½ SW½, 1.7 acres in SW½ SE½, 12.0 acres in SE½ SE½, Section 20; 38.0 acres in NE½ NE½, 35.2 acres in NW½ NE½, 14.9 acres in SW½ NE½, 8.1 acres in NE½ NW½, Section 29, Township 5 South, Range 1 East, W.M., is not in question in this proceeding.

ORS 540.621 provides that: "Whenever the owner of a perfected and developed water right certifies under oath to the Water Resources

Director that the water right has been abandoned by him and that he desires cancelation thereof, the Water Resources Director shall enter an order canceling the water right."

NOW, THEREFORE, it hereby is ORDERED that the water right for the use of 0.07 cubic foot per second of water from the well, with a priority date of January 15, 1969, for the supplemental irrigation of 24.8 acres in SW\(\frac{1}{2}\) SE\(\frac{1}{2}\) of Section 20, and 4.2 acres in NW\(\frac{1}{2}\) NE\(\frac{1}{2}\), Section 29, Township 5 South, Range 1 East, W.M., is canceled.

It is FURTHER ORDERED that the certificate of water right recorded at Page 39024, Volume 31, State Record of Water Right Certificates is canceled, and in lieu thereof a new certificate be issued to John Beck covering that part of the water right not in question for the appropriation of not to exceed 0.31 cubic foot per second of water from the well, with a priority date of January 15, 1969, for the supplemental irrigation of 15.6 acres in SE½ SW½, 1.7 acres in SW½ SE½, 12.0 acres in SE½ SEP, Section 20; 38.0 acres in NE½ NE½, 35.2 acres in NW½ NE½, 14.9 acres in SW½ NE½ and 8.1 acres in NE½ NW½, Section 29, Township 5 South, Range 1 East, W.M.
