O R D E R
APPROVING APPLICATION

On March 31, 1941, Wm. S. and Kenneth DeHaas of Eagle Point, Oregon, filed an application for approval of a change in point of diversion of water from Rogue River.

Certificate of water right recorded at Page 10543, Volume 10, State Record of Water Right Certificates, was issued to John Hall, confirming a right to the use of 0.22 cubic foot per second of the waters of Rogue River for the irrigation of 4 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ and 14 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 21, Township 34 South, Range 1 West, W. M., with a date of priority of July 5, 1928, through the Johnson Bros. Ditch, the point of diversion of such ditch being located 1,320 feet north and 800 feet west from the southeast corner of Section 16, Township 34 South, Range 1 West, W. M.

The applicants herein, who are purchasing under contract from D. E. Millard and F. D. Gaskell 10 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 21, Township 34 South, Range 1 West, W. M., propose to change the present point of diversion for the irrigation of said 10 acres to a point downstream to be located north 50° west 1,500 feet from the southeast corner of Section 21, Township 34 South, Range 1 West, W. M.

Notice by publication, as provided by Section 116-606, O. C. L. A., was given in the Medford News, a newspaper of general circulation in Jackson County, for a period of at least three weeks and not less than one publication each week, being the issues of June 6, 13, 20, and 27, 1941.

D. E. Millard and F. D. Gaskell having submitted their written approval to the proposed change in point of diversion and no objections having been filed, it appears that the proposed change in point of diversion may be made without injury to existing rights and the application should be approved.

Now, THEREFORE, it hereby is ORDERED that the proposed change in point of diversion of water from Rogue River for the irrigation of 10 acres in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 21, Township 34 South, Range 1 West, W. M., to-wit: From a point located 1,320 feet north and 800 feet west from the southeast corner of Section 16, Township 34 South, Range 1 West, W. M., to a point downstream to be located north 50° west 1,500 feet from the southeast corner of Section 21, Township 34 South, Range 1 West, W. M., be and the same hereby is approved.
