Authority

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Applicant

Findings of Fact

- 1. On March 24, 2014, STANFIELD HUTTERIAN BRETHREN, filed an application to change the point of diversion and place of use under Certificates 52222 and 56158 and change the place of use under Certificates 64411, 76052, and 87073. The Department assigned the application number T-11770.
- 2. Notice of the application for transfer was published on April 8, 2014, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. On August 18, 2014, the agent and certified water right examiner, Bill Porfily and Dale VanSchoiack, were contacted by e-mail regarding items in the application maps that needed to be addressed. Specifically:
 - a. Acreage under Certificate 56158 was missing from the "from" map in the SE¹/₄ NW¹/₄, Section 2, T 4 N, R 26 E, WM.
 - b. Acreage under Certificate 76052 in Lot 3 (NE¼ NW¼), Sec. 24, T 4 N, R 26 E, WM was mislabeled on the "to" map as being 33.3 acres, whereas it should be labeled 34.3 acres.
- 4. On September 8, 2014, amended "to" and "from" transfer application maps were received by the Department addressing the deficiencies described in Finding No. 3.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 5. On October 6, 2014, the Department sent a copy of the revised draft Preliminary Determination proposing to approve Transfer Application T-11770 to the applicant. The revised draft Preliminary Determination cover letter set forth a deadline of October 23, 2014, for the applicant to respond. The applicants requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicants are authorized to pursue the transfer.
- 6. On December 8, 2014, the Department issued a Preliminary Determination proposing to approve Transfer Application T-11770 and sent a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on December 16, 2014, and in the East Oregonian newspaper on December 13 and 20, 2014, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

19. The Oregon Department of Fish and Wildlife has determined that a fish screen is necessary at the new point of diversion to prevent fish from entering the diversion and that the diversion is currently equipped with an appropriate fish screen.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 20. Water has been used within the last five years according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 21. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights was present within the five-year period prior to submittal of Transfer Application T-11770.
- 22. The proposed changes would not result in enlargement of the rights.
- 23. The proposed changes would not result in injury to other water rights.

Conclusion of Law

The change in points of diversion and change in places of use proposed in Transfer Application T-11770 are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- The change in point of diversion and change in places of use proposed in Transfer Application T-11770 are approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 52222, 56168, 64411, 76052, 87073, and any related decree.

- 3. Water right certificates 52222, 56168, 64411, 76052, and 87073 are cancelled. A new certificate will be issued describing that portion of Certificate 87073 not affected by this transfer.
- 4. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.
- 5. The water user shall operate and maintain an approved fish screen at the new point of diversion. If Oregon Department of Fish and Wildlife (ODFW) determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.
- 6. The former places of use of the transferred rights shall no longer receive water under the rights.
- 7. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2016**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 8. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.
