Findings of Fact

1. On July 16, 2013, the Department issued an order approving Transfer Application T-11571. The order was recorded at Special Order Volume 89, Pages 1083 - 1097.
2. The order contains scrivener's errors in the omission of a proposed additional point of appropriation for Certificate 80850 and the layered supplemental water right. The order cited the addition of the following three points of appropriation as follows:
