ORDER APPROVING A CHANGE IN POINT OF APPROPRIATION

Pursuant to ORS 537.211, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, PERMIT AMENDMENT T-8319 submitted by

WALT AND RUTH WIESE 16245 SW BEEF BEND ROAD SHERWOOD, OREGON 97140.

The permit to be modified is Permit G-12623 with a date of priority of FEBRUARY 3, 1994. The permit allows the use of A WELL, in the THOMAS CREEK BASIN, for PRIMARY IRRIGATION OF 165.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 128.7 ACRES. The amount of water to which this permit is entitled is limited to an amount actually beneficially used and shall not exceed 3.67 cubic feet per second, if available at the original well; SW¼ NE¼, SECTION 22, T 38 S, R 19 E, W.M.; 2570 FEET SOUTH AND 3180 FEET EAST FROM THE NW CORNER OF SECTION 22, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

NOTICE: Under the provisions of OAR 137-004-0080, the applicant may petition for reconsideration of this order. The petition shall set forth specific grounds for reconsideration. The petition for reconsideration must be filed within 60 days after the date this order is served.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the point of appropriation to:

SW¼ NE¼, SECTION 22, T 38 S, R 19 E, W.M.; 2375 FEET SOUTH AND 3330 FEET FROM THE NW CORNER OF SECTION 22.

THIS CHANGE TO AN EXISTING WATER PERMIT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The quantity of water diverted at the new point of appropriation (well) shall not exceed the quantity of water lawfully available at the original point of appropriation.
- 2. Water shall be acquired from the same aquifer as the original point of appropriation.
- 3. All other terms and conditions of the permit remain the same.

Permit G-12623, in the name of WALT AND RUTH WIESE is amended as described herein.
