Authority

ORS 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

Background

- 1. On February 21, 2006, Burns Paiute Tribe filed a transfer application to change the point of appropriation and character of use under Certificates 20244, 20245, and Silvies decree number 14015. The Department assigned the application number T-10100.
- On September 4, 2007, Bill Reynolds submitted revised maps and further clarification of the proposed changes.
- The entirety of the first right to be transferred is as follows:

25.7 acres

Priority Date: October 20, 1947

Quantity:

0.32 cubic foot per second (cfs)

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 16. Notice of the application for transfer was published on March 14, 2006, pursuant to ORS 540.520 and OAR 690-380-4000.
- 17. On September 19, 2007, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-10100 to the applicant. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 18. On January 31, 2008, the Department issued a Preliminary Determination proposing to approve Transfer T-10100 and mailed a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on February 5, 2008, and in the Burns Times Herald newspaper on April 16, 23 and 30, 2008, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

Transfer Review Criteria (OAR 690-380-4010)

- 19. Water has been used within the last five years according to the terms and conditions of the rights, and there is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 20. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights is present.
- 21. The proposed change would not result in enlargement of the rights.

22. The proposed change would not result in injury to other water rights.

Conclusions of Law

The changes in point of appropriation and character of use proposed in application T-10100 are consistent with the requirements of ORS 537.705 and 540.505 to 540.580, and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. The changes in point of appropriation and character of use proposed in application T-10100 are approved.
- 2. Water right certificates 20244 and 20245 are cancelled. The decree number 14105 in the name of Brown, N. & Sons as tabulated in the inchoate adjudication for the Silvies River, recorded in Volume 9, Page 176, is modified.
- 3. The right to use of the water is restricted to beneficial use at the place of use as re-described, and is subject to all other conditions and limitations contained in Certificates 20244, 20245 and decree number 14015.
- 4. Water shall be acquired from the same aquifer (water source) as the original point of appropriation.
- 5. The quantity of water diverted at the new point of appropriation shall not exceed the quantity of water lawfully available at the original point of appropriation.
- 6. When required by the Department, the water user shall install and maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 7. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2009.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 8. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
