Authority

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

Background

- 1. On August 6, 2010, BETTY KNOEBEL filed an application to change the place of use under Certificates 17227, 85714 and 83349. The Department assigned the application number T-11117.
- 2. The portion of the first right to be transferred is as follows:

Certificate: 17227 in the name of L.H. WYANT (confirmed by Little Butte Creek

Decree)

Use: IRRIGATION of 3.0 ACRES

Priority Date: MAY 12, 1896

Rate: 0.075 CUBIC FOOT PER SECOND MEASURED AT THE HEAD OF

- 9. Notice of the application for transfer was published on August 17, 2010, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 10. On September 22, 2010, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-11117 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of October 20, 2010, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 11. On October 22, 2010, the Department issued a Preliminary Determination proposing to approve Transfer Application T-11117 and mailed a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on October 26, 2010, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 12. Water has been used within the last five years according to the terms and conditions of the right. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 13. A diversion structure and ditch sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-11117.
- 14. The proposed changes would not result in enlargement of the rights.
- 15. The proposed changes would not result in injury to other water rights.

Conclusions of Law

The change in place of use proposed in Transfer Application T-11117 is consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000.

Now, therefore, it is ORDERED.

- 1. The change in place of use proposed in Transfer Application T-11117 is approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 17227, 83349 and 85714, and any related decree.
- 3. Water right certificates 17227 and 83349-are cancelled. New certificates will be issued describing the portion of the rights not affected by this transfer.
- 4. Water right certificate 85714 is modified. The Department will issue a superseding certificate describing the right when it determines that is necessary for record keeping.
- 5. The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.
- 6. The water user shall maintain the existing headgate and shall make such improvements as may be required by the Department.
- 7. The former place of use of the transferred rights shall no longer receive water under the rights.
- 8. The approved change shall be completed and full beneficial use of the water shall be made on or before **October 1, 2012**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the change and full beneficial use of the water.
- 9. When satisfactory proof of the completed change is received, new certificates confirming the rights transferred under Certificates 17227 and 83349 will be issued.
