CONCLUSIONS OF LAW

1. The temporary transfer application submitted by Dickman Farms Inc. included the information required by ORS 540.520(2).
2. The temporary transfer application submitted by Dickman Farms Inc. was accompanied by the appropriate fees as set forth in ORS 536.050.
3. The proposed transfer complies with the requirements of ORS 540.523.


4. The Director should approve the transfer because the application satisfies the criteria and requirements of ORS 540.520(2) and ORS 540.523 resulting in no injury to other water rights.

ORDER

It is hereby ORDERED:

1. The proposed changes to the existing water rights may be made provided the following conditions are met by the water user:
 - a. The change is temporary. The change shall be effective for the 2003 irrigation season upon issuance of this order.
 - b. The approval of this temporary transfer may be revoked or modified at any time if the Department finds the change causes injury to any existing water right.
 - c. The authorized places of use shall not be irrigated as part of these water rights during the 2003 irrigation season.
 - d. The use of water under these rights shall revert to the authorized place of use at the end of the 2003 irrigation season.
 - e. All restrictions and limitations contained in the permit and certificate for the water rights describing the authorized place of use apply to the use of water on the lands described by the temporary change in place of use. Thus, the maximum allowable diversion from Well #1 is 0.28 cfs and from Well #3 is 0.22 cfs; with the total application of irrigation water on the receiving lands during the 2003 irrigation season not to exceed 2.5 acre-feet per acre from all sources and rights.
 - g. The use of the remaining water rights described by Certificates 55120 and 72133 shall continue to be in accordance with the terms and conditions of Certificates 55120 and 72133.
