ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8735 submitted by

BUCKLEY D. AND KATHRYN CHURCH

CHRISTMAS VALLEY, OREGON 97641.

The FIRST right to be modified, as evidenced by a PORTION of Certificate 55702, was perfected under Permit G-9015 with a date of priority of AUGUST 7, 1980. The right allows the use of A WELL, in the FORT ROCK BASIN, for IRRIGATION OF 5.1 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.06 cubic foot per second, if available at the original well; SW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 29, T 26 S, R 18 E, W.M.; 1290 FEET NORTH AND 1260 FEET EAST FROM THE SW CORNER, SECTION 29, or its equivalent in case of rotation, measured at the well.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with the right perfected under Permit G-9015 shall not exceed 2.97 cfs, the capacity of this well at the time of perfection of this right.

The authorized place of use is as follows:

The SECOND right to be modified, as evidenced by a PORTION of Certificate 55704, was perfected under Permit G-10172 with a date of priority of October 4, 1983. The right allows the use of A WELL, in the FORT ROCK BASIN, for IRRIGATION OF 109.37 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.36 cubic feet per second, if available at the original well; SW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 29, T 26 S, R 18 E, W.M.; 1290 FEET NORTH AND 1260 FEET EAST FROM THE SW CORNER, SECTION 29, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

SW $\frac{1}{4}$ SE $\frac{1}{4}$ 34.10 ACRES

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.



THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed changes shall be completed on or before October 1, 2003.
2. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
3. The former place of use shall no longer be irrigated as part of this water right.

Certificates 55704 and 55702 are canceled. New certificates will be issued to confirm those portions of the rights NOT involved in this transfer. When satisfactory proof of the completed changes are received, new certificates confirming these water rights will be issued.
