IN THE MATTER OF THE APPLICATION OF WARREN EDMUNDS FOR APPROVAL OF A CHANGE IN PLACE OF USE OF WATER WITHIN THE BOUNDARIES OF THE SQUAW CREEK IRRIGATION DISTRICT.

ORDER APPROVING APPLICATION

On October 10, 1941, Warren Edmunds of Sisters, Oregon, filed an application for approval of a change in place of use of water within the boundaries of the Squaw Creek Irrigation District.

By an order of the State Engineer dated September 11, 1930, the State Engineer approved an application of Warren Edmunds wherein a water right appurtenant to 40 acres in the NE_{4}^{1} NE_{4}^{1} , Section 4, Township 15 South, Range 11 East, W. M., with a date of priority of 1895, was transferred to 13 acres in the SW_{4}^{1} SE_{4}^{1} , Section 29, 3 acres in the NE_{4}^{1} NE_{4}^{1} , Section 32, and 24 acres in the NW_{4}^{1} NW_{4}^{1} , Section 33, Township 14 South, Range 11 East, W. M.

The applicant herein, owner of the above-described lands to which the water was transferred, proposes to transfer such water right to 33 acres in the $SW_{4}^{\frac{1}{2}}$ $NW_{4}^{\frac{1}{2}}$ and 7 acres in the $SE_{4}^{\frac{1}{2}}$ $NW_{4}^{\frac{1}{2}}$, Section 30, Township 15 South, Range 11 East, W. M.

Notice by publication as provided by Section 116-606, O. C. L. A., was not given in connection with this application for the reason that said section provides that notice is not required in applications for only a change in place of use of water.

All the lands involved being within the boundaries of the Squaw Creek Irrigation District and the district having approved the application on October 7, 1941, it appears that such change in place of use may be made without injury to existing rights and the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use of water be and the same hereby is approved and that the water right hereinbefore described as appurtenant to 13 acres in the SW SEL, Section 29, 3 acres in the NEL NEL, Section 32, and 24 acres in the NW4 NW4, Section 33, Township 14 South, Range 11 East, W. M., having a date of priority of 1895, be severed therefrom and simultaneously and without loss of priority transferred to 33 acres in the SW_4^1 NW_4^1 and 7 acres in the SE1 NW1, Section 30, Township 15 South, Range 11 East, W. M.

It is FURTHER ORDERED that complete application of water to beneficial use on said lands shall be made on or before October 1, 1942, or such extension of time as may be granted by the State Engineer for good cause shown.
