Authority

Oregon Revised Statute (ORS) 536.750 establishes the process in which a water right holder may submit a request to temporarily transfer the use, place of use or point of diversion of water in the event of a declaration of drought, without complying with the notice and waiting requirements under ORS 540.520. Oregon Administrative Rule (OAR) Chapter 690, Division 019 implements the statutes and provides the Department's procedures and criteria for evaluating drought transfer applications.

Findings of Fact

- On April 17, 2015, BOHLENDER COLORADO FARMS LLC filed an application to temporarily change the place of use under Certificates 85585, 84863, 84866, 84862 and 84867 for the remainder of the 2015 irrigation season or the term of the Governor's declared drought, whichever is shorter. The Department assigned the application number T-12037.
- 2. Notice of the application for transfer was published on April 21, 2015, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. On April 24, 2015, the Department contacted the applicant's agent by written correspondence to notify them of the deficiencies in the application. The applicant's agent responded on April 27, 2015, resolving all deficiencies.

Temporary Drought Transfer Review Criteria

- 14. Water has been used within the last five years according to the terms and conditions of the rights. There is no evidence available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 15. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights are present.
- 16. The Governor issued an executive order on March 16, 2015, declaring a state of drought emergency in Malheur County due to drought and extreme weather conditions, which is still in effect and the water right proposed for transfer is on lands included in the area covered by the drought order.
- 17. The proposed changes would not result in enlargement of the rights.
- 18. The proposed changes would not result in injury to other water rights. This finding is made through an abbreviated review recognizing that the transfer may be revoked under OAR 690-019-055(3) if injury to existing water rights is shown and cannot be mitigated to the satisfaction of the Director and injured parties.

Conclusions of Law

The temporary change in places of use proposed in Temporary Drought Transfer Application T-12037 is consistent with the requirements of ORS 536.750 and OAR 690-019-0055.

Now, therefore, it is ORDERED:

- 1. The temporary change in places of use proposed in Temporary Drought Transfer Application T-12037 is approved.
- 2. The former places of use **shall not** be irrigated as part of these water rights during the remainder of the 2015 irrigation season or until the end of the Governor's declared drought, whichever occurs first.
- 3. The approval of this temporary drought transfer may be revoked or modified if the Department finds the changes cause injury to any existing water right.
- 4. The use of water at the temporary places of use authorized by this transfer shall be in accordance with the terms and conditions of Certificates 85585, 84863, 84866, 84862 and 84867. The use shall revert to the authorized place of use at the end of the 2015 irrigation season.
- 5. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- 6. The proposed change in places of use shall revert to the authorized places of use at the end of the 2015 irrigation season or the end of the Governor's declared drought, whichever occurs first.
- 7. The use of the remaining water rights described by Certificates 85585, 84863, 84866, 84862 and 84867 shall continue to be in accordance with the terms and conditions of Certificates 85585, 84863, 84866, 84862 and 84867.
