Authority

ORS 537.225 establishes the process in which a water right permit holder may submit a request for full or partial assignment of a water right permit and issuance of replacement permits. OAR Chapter 690, Division 325 establishes the requirements and procedures to be used by the Department to evaluate an application by a landowner of record holding a water right permit for irrigation, nursery, temperature control, stock watering or agricultural water use, to assign all or part of the water right permit and to issue replacement permits to reflect an assignment from the current permit holder to one or more additional permit holders.

Findings of Fact

Background

- 1. On November 21, 2016, EDITH PIERCE, and SUSAN AND KUEN LEE filed an application for partial assignment of Water Right Permit G-13980 and requested issuance of replacement permits. The Department assigned the application number T-12524.
- 2. On July 8, 2015, the Department cancelled Permit G-13980 in accordance with ORS 537.260. On July 27, 2015, the Department received a timely request for reconsideration of the cancellation. On July 30, 2015, the Department reinstated Permit G-13980.
- On October 22, 2015, the Department approved an assignment of Permit G-13980 from J. D. and Edith Pierce to Edith Pierce, Lynette Pierce, Bryan Joyce, Susan and Kuen Lee, and Edward W. and Theresa E. Shepard.
- 4. On May 6, 2016, the Department approved an extension of time for complete application of water under Permit G-13980 to October 1, 2020.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

For the irrigation of in ground nursery plants the amount of water diverted is limited to ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre feet per acre per year. The use of water for NURSERY OPERATIONS may be made at anytime, during the period of allowed use specified above, that the use is beneficial. - 8. Notice of the application for the assignment of the water right permit and request for issuance of replacement water right permits was published in the Department's weekly notice on January 10, 2017, pursuant to ORS 537.325(3)(e) and OAR 690-325-0080. No comments were filed in response to the notice. In addition on January 3, 2017, the Department provided copies of the draft Proposed Final Order, draft replacement permits, the application, map, and existing water right permit to each owner of land upon which the water right permit is located.
- 9. On February 28, 2017, the Department issued a Proposed Final Order considering any comments received, and sent a copy to the applicant, each owner of land upon which the water right permit is appurtenant. Notice of the Proposed Final Order was published in the

- Department's weekly notice on March 7, 2017. No protests were filed in response to the notice.
- 10. On April 20, 2017, the Department found multiple error's in the Proposed Final Order that was issued on February 28, 2017.
- 11. On April 27, 2017, the Department issued a Superseding Proposed Final Order considering any comments received and amending the error's, and sent a copy to the applicant, each owner of land upon which the water right permit is appurtenant. Notice of the Proposed Final Order was published in the Department's weekly notice on May 2, 2017. No protests were filed in response to the notice.

Split a Permit Review Criteria

12. The Department has verified the mailing address of each owner of the authorized place of use identified on the map contained in the application as follows:

- 13. The deeds supplied with the application, match the properties proposed for assignment. OAR 690-325-0070(1)(b).
- 14. The applicants affirmed the most recent water use under the permit has been exercised within the relevant terms and conditions of the water right permit. OAR 690-325-0070(1)(c).
- 15. The assignment and issuance of replacement permits, as outlined in Finding of Fact #7 above, will not result in injury to other water right holders. OAR 690-325-0070(1)(d).

- 16. The assignment and issuance of replacement permits, as outlined in Finding of Fact #7 above, will not result in enlargement of the permit. OAR 690-325-0070(1)(d).
- 17. The assignment and issuance of replacement permits does not alter any other terms of Permit # G-13980.

Conclusions of Law

The assignment and issuance of replacement permits proposed by Application T-12524 are consistent with the requirements of ORS 537.225 and OAR Chapter 690, Division 325. If no protests are filed, an Order will be issued which will include the following:

Now, therefore, it is ORDERED:

- 1. The assignment and issuance of replacement permits proposed by Application T-12524 are approved.
- 2. Permit G-13980, in the names of Edith Pierce, Lynette Pierce, Bryan Joyce, Susan and Kuen Lee, and Edward W. and Theresa E. Shepard, is cancelled. Permit G-17747, in the names of Edith Pierce and Susan and Kuen Lee, and Permit G-17748 in the names of Lynette Pierce, Edward and Theresa Shepard and Bryan Joyce, are issued to supersede Permit G-13980.
- 3. All other terms and conditions under Permit G-13980 are incorporated into Permits G-17747 and G-17748.
