ORDER APPROVING A CHANGE IN PLACE OF USE  
AND POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 9327 submitted by

GREG and SANDRA VISCONTY  
62630 BOOTH LANE  
P.O. BOX 1688  
LAGRANDE, OREGON 97850.

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for UNION County as evidenced by a PORTION of Certificate 79513. The decree is recorded in the Order Record of the Water Resources Director in Volume 8, at Page 1. The date of priority is 1872.

The right allows the use of the GRANDE RONDE RIVER, a tributary of the SNAKE RIVER, for IRRIGATION OF 3.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed ONE-FORTIETH of

one cubic foot per second per acre, or its equivalent for each acre irrigated, if available at the authorized point of diversion: SW¼ SW¼, SECTION 31, T 2 S, R 38 E, W.M.; ORODELL DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right for the same lands, is limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The authorized place of use is located as follows:

SE¼ NW¼            3.0 ACRES  
SECTION 23  
TOWNSHIP 2 SOUTH, RANGE 38 EAST W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes to change the place of use to:

NW¼ SE¼            3.0 ACRES (TAX LOT 1400)  
SECTION 28  
TOWNSHIP 2 SOUTH, RANGE 38 EAST W.M.

The applicant further proposes to change the point of diversion to:

SW¼ SW¼, SECTION 31, T 2 S, R 38 E, W.M.; 1858.33 FEET SOUTH AND 80.84 FEET EAST FROM THE W¼ CORNER, SECTION 31.

THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:


1. The proposed changes shall be completed on or before October 1, 2004.

2. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.
3. **PRIOR** to the diverting of water at the new point of diversion, the water user **SHALL** maintain the headgate, in-line flow meter, weir, or other suitable device used for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same surface water source as the original point of diversion.
5. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 79513 is canceled. A new certificate will be issued to confirm that portion of the rights NOT involved in this transfer. When satisfactory proof of the completed changes are received, a new certificate confirming this water right will be issued.
