ORDER APPROVING AN ADDITIONAL POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8639 submitted by

R. DOUGLAS POWELL
6153 MILL CREEK ROAD
THE DALLES, OREGON 97058.

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for Wasco County as evidenced by a PORTION of Certificate 5722. The decree is recorded in the Order Record of the Water Resources Director in Volume 8, at Page 119. The date of priority is 1855.

The right allows the use of water from a MILL CREEK, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 8.7 ACRES AND STOCK USE. The amount of water to which this right is entitled is limited to

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

an amount actually beneficially used and shall not exceed 0.145 cubic foot per second, if available at the authorized point of diversion: SANDOZ DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right for the same lands, is limited to ONE-SIXTIETH of one cubic foot per second per acre during the irrigation season from APRIL 1 TO OCTOBER 1; and ONE-FORTIETH of one cubic foot per second for each one thousand head of stock, if available at the original point of diversion.

The authorized place of use is located as follows:

SW¼ SE¼ 1.2 ACRES
SE¼ SE¼ 7.5 ACRES
SECTION 14
TOWNSHIP 1 NORTH, RANGE 12 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes to add an additional point of diversion to:

SE¼ SE¼, SECTION 14, T 1 N, R 12 E, W.M.; 210 FEET NORTH AND 1280 FEET WEST FROM THE SE CORNER, SECTION 14.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 2003.
2. The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.
