On July 6, 1981, an application was filed in the office of the Water Resources Director by Max M. Bibby for approval of a change in place of use of water from a well, pursuant to the provisions of 537.705.

The certificate recorded at page 44211, Volume 36, State Record of Water Right Certificates, in the name of Leslie F. Klampe, describes a right which includes the use of not to exceed 0.03 cubic foot per second from a well for irrigation of a certain 2.2 acres in NE 1/4 NW 1/4, Section 27, Township 6 South, Range 2 West, WM, with a date of priority of March 4, 1971.

Water for the said right is diverted from a well located 240 feet South and 2,400 feet West from the Northeast Corner of Section 27, being within the NW 1/4 NE 1/4 of Section 27, Township 6 South, Range 2 West, WM.

The applicant herein, owner of the lands above described, proposes to sever the right therefrom and, without loss of priority, to irrigate in lieu thereof a certain 0.1 acre in SE 1/4 SW 1/4, 0.5 acre in SW 1/4 SE 1/4, Section 22, and 1.6 acres in NE 1/4 NW 1/4, Section 27, Township 6 South, Range 2 West, WM.

Clifton R. King, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in place of use, as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that NO time need be fixed for completion as the change in place of use is completed.

The order of the Water Resources Director entered July 14, 1981, provided for cancellation of a portion of the right described by certificate of water right recorded at page 44211, Volume 36, State Record of Water Right Certificates, NOT involved in this transfer proceeding; therefore,

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, the certificate of water right recorded at page 44211, Volume 36, State Record of Water Right Certificates, be canceled; and a confirming certificate of water right be issued to Leslie F. Klampe.
