GRDER APPROVING TRANSFER NO. 2381

On May 14, 1970, Pins Tree Pipeline Association filed an application in the office of the State Engineer for the approval of a change in point of diversion of water from Hurricane Creek, pursuant to the provisions of ORS 540.510 to 540.530.

By Decree of the Circuit Court for Wallowa County, Oregon, entered January 20, 1919, In the Matter of the Determination of the Relative Rights to the Use of the Waters of Wallowa River and its Tributaries, a water right was established in the name of Rosetta F. Shinn for the use of the waters of Hurricene Creek for domestic and stock use and the irrigation of 80.0 acres in the W% NWM, Section 25, Township 2 South, Range 44 East, W.M., by means of the Pine Tree Ditch from a point of diversion located in the NEW SEM, Section 35, Township 2 South, Range 44 East, W.M., with a date of priority of 1883, and 36.5 acres in SEM NWM and 20.0 acres in NEW SWM, Section 25, Township 2 South, Range 44 East, W.M. by means of the Shinn Ditch from a point of diversion located in the SWM SWM, Section 25, Township 2 South, Range 44 East, W.M., with a date of priority of 1892. This right is evidenced by certificate recorded at page 3156, Volume 4, State Record of Water Right Certificates.

The applicant herein, owner of the lands above described, proposes to convey water to these lands by means of the Hurricane Ditch from a point of diversion to be located S 76° 02' W 49 feet from the NE corner of Section 3 being within the NE% NE% or Section 3,

Township 3 South, Range 44 East, W.M.

Notice of the filing of the application was given by publication setting forth a time and place certain for hearing objections to the proposed change in point of diversion of water, if any there were, namely: at the county courthouse in Enterprise, Oregon, on August 27, 1970, at 9:30 s.m. The notice was published in the Wellows County Chieftein, a newspaper printed and having general circulation in Wellows County, Oregon, for a period of three weeks in the issues of July 2, 9, and 16, 1970. The date set for hearing in said notice was not less than thirty days after the last publication of the notice.

Mr. Walter L. Astwood, Watermaster of District No. 7, has filed a report to the effect that the proposed change in point of diversion of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the change in point of diversion of water from Hurricone Creek, to-wit:

From a point located in the NEW SEW, Section 35, Township 2 South, Range 44 East, W.M.

From a point located in the SWK SWK, Section 25, Township 2 South, Range 44 East, W.M.

To a point to be located S 76° 02' W 49 feet from the NE corner of Section 3 being within the NE% NE% of Section 3, Township 3 South, Range 44 East, W.M.

for domestic and stock use and the irrigation of 80.0 acres in the W% NWA, Section 25, Township 2 South, Range 44 East, W.M., with a date of priority of 1883, and 36.5 acres in SEX NWA and 20.0 acres in NEX SWX, Section 25, Township 2 South, Range 44 East, W.M., with a date of priority of 1892, is approved.

It is FURTHER ORDERED that construction work shall be

completed and the change in point of diversion of water made on or before October 1, 1971.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion and shall not exceed 1% acre feet per acre during any period of 30 days prior to July 31st of each year, and thereafter not to exceed 1.0 acre foot per acre during the entire remainder of the irrigation season.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install headqates and measuring devices.

That the diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled.

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that certificate of water right heretofore issued to Rosetta F. Shinn and recorded at page 3156, Volume
4, State Record of Water Right Certificates, is canceled and upon
receipt of proof satisfactory to the State Engineer of completion of
the authorized change in point of diversion, a certificate of water
right shall be issued to Pine Tree Pipeline Association confirming
said change in point of diversion.
